3 CHAIRPERSON MILLER: Good morning,
4 everyone. I would like to welcome you to the
5 regularly scheduled meeting of the District of
6 Columbia Alcoholic Beverage Control Board.
7 Today is January 8, 2014.

8 My name is Ruthanne Miller. I'm
9 the Chairperson. And joining me to my far
10 right is Mr. Donald Brooks. And to my
11 immediate right is Mr. Nick Alberti. And to
12 my immediate left is Mr. Mike Silverstein.
13 The Board has four Members in attendance for
14 the conduct of business this morning with
15 three constituting a quorum.

16 Copies of today's hearing calendar
17 and agenda are available at the receptionist
18 desk. Please be aware that these proceedings
19 are being recorded by a court reporter.
20 Accordingly, we must ask you to refrain from

13 ^U 405(b) of the Open Meetings Act, enter a
14 closed meeting during or after the public
15 hearing on a case to consult with an attorney
16 to obtain legal advice, discuss settlement
17 agreements or deliberate upon a decision in an
18 adjudication proceeding.
