3 CHAIRPERSON MILLER: Okay. The next  
4 case on the calendar or cases are Case No. 14-  
5 251-00003 and 14-251-00003(a), District located  
6 at 2473 18th Street, N.W., License No. 92742, in  
7 ANC-1C.

8 MS. SCHMIDT: Good morning, Amy  
9 Schmidt, Assistant Attorney General on behalf of  
10 the District of Columbia.

11 CHAIRPERSON MILLER: Good morning. Is  
12 anybody here from District? Not hearing or  
13 seeing anyone come forward, Ms. Schmidt, do you  
14 have any information whether or not the  
15 respondent is intending to come to this hearing?

16 MS. SCHMIDT: I do not know. All I

15 available? Okay. All right. Then do Board  
16 Members have any questions?

17 All right. Then I would move that we  
18 continue this case until March 11th at 11:00 a.m.  
19 Do I have a second?

20 MEMBER ALBERTI: Second.

21 CHAIRPERSON MILLER: Mr. Alberti  
22 seconded the motion.

2 ALL: Aye.

3 CHAIRPERSON MILLER: All those  
4 opposed? All those abstaining? The motion  
5 passes 6-0-0. So this case is now set for a Show  
6 Cause Hearing March 11th at 11:00 a.m.
