4 going to call Case Number 12-CMP-00741 (sic),
5 Sushi Sai, located at 4221 Connecticut Avenue,
6 NW. License number 88557, in ANC 3F.

8 Seng Ren Dong and I'm the owner of the 4221
9 Connecticut Avenue, Sushi Sai Company.

11 Gebhardt on behalf of the Office of the

9 offer in compromise of \$350 to be paid today.

10 MR. DONG: Yes.

11 CHAIRPERSON MILLER: Any questions

13 offer in compromise of a \$350 fine to be paid
14 today. I move that we approve this offer in
15 compromise.
