3 CHAIRPERSON MILLER: The next case
4 is another Show Cause (Status) Hearing. It's
5 a few cases: Case Nos. 13-251-00032, 12-251-
6 00045, 13-251-00046 and 13-251-00047. This is
7 Ibiza located at 1222 First Street, N.E.,
8 License No. 74456, in ANC-6C.

9 When you are ready, if you would
10 introduce yourself for the record?

11 MR. RIVERO: Good morning, Board
12 Members. Fernando Rivero for the District of
13 Columbia.

14 CHAIRPERSON MILLER: Is anybody
15 here from Ibiza?

16 MR. RIVERO: Apparently not.

17 CHAIRPERSON MILLER: No, it does
18 not look that way. Have you spoken with
19 anyone from there?

20 MR. RIVERO: I have had absolutely
21 no contact with the licensee. I did send an
22 email to someone who I thought might be a

1 representative of the licensee and did not

4 far as the Board is aware, there has been no
5 contact by them on the Agency or the Board.

6 MR. RIVERO: Right.

7 CHAIRPERSON MILLER: So we can set
8 this for a hearing on March 19, 2014 at 10:00
9 a.m. and I will note that my records show that
10 notice was issued on November 25, 2013 and
11 served on the respondent on November 29, 2013.

12 MR. RIVERO: The only
13 administrative matter I have is it might be
14 back to the Board on a hearing date change.

15 CHAIRPERSON MILLER: Okay.

16 MR. RIVERO: Depending on witness
17 availability. But obviously, I will continue
18 to do outreach to the licensee, so that we can
19 file a Consent Motion for a Hearing Date
20 Change.

21 CHAIRPERSON MILLER: Okay.

22 MR. RIVERO: I just don't have

1 that information, at this time.

2 CHAIRPERSON MILLER: To continue,
3 to postpone?

4 MR. RIVERO: Right. Because I
5 mean, I could get a date now, but --

6 CHAIRPERSON MILLER: Right.

7 MR. RIVERO: -- what if it doesn't
8 work for the licensee. I would rather just
9 communicate with the licensee first and see if
10 we have an agreement as to another date.

11 CHAIRPERSON MILLER: Exactly.
12 Okay. We will watch for that.

13 MR. RIVERO: That might end up
14 just having one date change as opposed to two.

15 CHAIRPERSON MILLER: Right. You
16 have a conflict, I assume?

17 MR. RIVERO: Yes.

18 CHAIRPERSON MILLER: Okay. Okay.

19 MR. RIVERO: Thank you.

20 CHAIRPERSON MILLER: Yes, okay,
21 thank you, Mr. Rivero.
