Summary Suspension (Status) Hearing for Roc
Bar. This is Case No. 12-251-00360.

11 apologies. This is a Summary (Status)
12 Hearing. And do we have an update, Ms.
13 Schmidt or Mr. Mpras? Who would like to give
14 us an update?

15 MR. MPRAS: Sir, all the -- per
16 the Board's order, all conditions have been
17 met and the venue was reinspected by ABRA
18 Investigator last week and found no violations
19 and the -- a new C of O was submitted to ABRA.

20 MS. SCHMIDT: Again, not to OAG.

21 MR. MPRAS: An oversight. I'll
22 make sure OAG gets a copy right away.

1 MS. SCHMIDT: Today is not my day.

2 ACTING CHAIRMAN ALBERTI: Okay.
