3 CHAIRPERSON MILLER: Good. Okay. The  
4 Board is back on the record for a hearing this  
5 afternoon, but before we get to that, we have a  
6 case involving an establishment that has been  
7 closed by the Chief of Police and a decision  
8 whether to keep that establishment closed.

9 And that is Case No. 15-251-00033,  
10 Halftime Sports Bar located at 1427 H Street,  
11 N.E., License No. 094107.

12 And I would move pursuant to D.C.  
13 Official Code § 25-826 that we summarily revoke  
14 the license of Halftime Sports Bar.

15 MEMBER SHORT: I second.

16 CHAIRPERSON MILLER: And that has been  
17 seconded by Mr. Short. And the grounds would be  
18 that the operation of the establishment presents  
19 an imminent hazard or danger to the health and  
20 safety of the public.

21 And that motion has been seconded.  
22 I'll now take a vote.

1 All those in favor say aye.

2 ALL: Aye.

3 CHAIRPERSON MILLER: All those  
4 opposed? All those abstaining? The motion  
5 passes 6-0-0.

6 And I'll note for the record that the  
7 licensee will have a right to appeal within 72  
8 hours after receipt of notice of this decision.

9 Okay. Thank you.
