CHAIRPERSON MILLER: All right.

Next on the calendar is a Show Cause Hearing,  
Case No. 12-CMP-00130, 7th L Street Market,  
located at 700 L Street, S.E., License No.  
88611 in ANC-6B.

MS. CHOE: Hi, good morning.

CHAIRPERSON MILLER: Good morning.

I'm going to start with introductions for the  
record.

MS. ZANIEL: Good morning again,  
Maureen Zaniel on behalf of the District.

MS. CHOE: Yes, this is Eun Choe  
from 7th L Street Market.

CHAIRPERSON MILLER: Okay. Are  
you the owner?

MS. CHOE: Yes, ma'am.

CHAIRPERSON MILLER: All right.  
So this is a Show Cause Hearing, but, first,  
I want to ask, Ms. Zaniel, if there are any  
preliminary matters?

1 MS. ZANIEL: Yes. Ms. Choe and I  
2 have spoken on more than one occasion and we  
3 have an offer in compromise that we recommend  
4 to the Board.

5 And it consists of this, that  
6 Charge 1 be dismissed and as to Charge 2, Ms.  
7 Choe would pay a fine of \$350 and that's  
8 payable today.

9 CHAIRPERSON MILLER: Ms. Choe?

10 MS. CHOE: Yes.

11 CHAIRPERSON MILLER: I just need  
12 to confirm with you that you agree to the  
13 offer in compromise of dismissing the first  
14 charge and you are paying a penalty of \$350  
15 today for the second charge. Is that what you  
16 agreed to?

17 MS. CHOE: Yes, ma'am.

18 CHAIRPERSON MILLER: Okay. And do  
19 you understand you waive your right to a  
20 hearing?

21 MS. CHOE: Yes, I do.

22 CHAIRPERSON MILLER: Okay. Good.

1 Are there any questions by Board Members? All  
2 right. Then I would move that we approve this  
3 offer in compromise, dismissing Charge 1, and  
4 payment of \$350 today for Charge 2.

5 Do I have a second?

6 MEMBER BROOKS: Second.

7 CHAIRPERSON MILLER: Mr. Brooks  
8 has seconded the motion.

9 All those in favor say aye.

10 ALL: Aye.

11 CHAIRPERSON MILLER: All those  
12 opposed? All those abstaining? The vote is  
13 5-0-0 to accept this offer in compromise.

14 MS. ZANIEL: Thank you.

15 MS. CHOE: Thank you.

16 MS. ZANIEL: And will staff tell  
17 Ms. Choe where to give her check?

18 CHAIRPERSON MILLER: Sure.

19 MS. CHOE: Yes, ma'am.

20 MEMBER ALBERTI: Someone will be  
21 with you in a moment.

22 MS. CHOE: Sure, sure. Yes, sir.
