CHAIRPERSON MILLER: The next case is Case No. 12-CMP-000296, Scion Restaurant, located at 2100 P Street, N.W., License No. 88727 in ANC-2B.

Are the parties here in this case? Okay. I was given a note that the licensee was stuck in traffic, so we will pass on this case and come back to it when they get here.

MS. PHILLIPS: So what's your case?

MS. LIU: Scion.

MS. PHILLIPS: Scion? Ah, Scion.

CHAIRPERSON MILLER: Yes.

MS. PHILLIPS: Do you want to call her now?

CHAIRPERSON MILLER: Sure. Okay. Sure. Yes, because we did go by your case.

Okay. So if you would introduce

1 yourselves for the record? We are calling  
2 again the case of Scion, Case No. 12-CMP-  
3 00296. Okay.

4 MS. LIU: Joanne Liu, owner of  
5 Scion Restaurant.

6 CHAIRPERSON MILLER: Okay.

7 MS. PHILLIPS: Louise Phillips,  
8 Assistant Attorney General, for the District  
9 of Columbia.

10 CHAIRPERSON MILLER: Okay. Ms.  
11 Liu, did you receive notice of this hearing?

12 MS. LIU: I did.

13 CHAIRPERSON MILLER: Did you read  
14 it?

15 MS. LIU: I did.

16 CHAIRPERSON MILLER: Did you  
17 understand it?

18 MS. LIU: I did.

19 CHAIRPERSON MILLER: Okay. And do  
20 you waive the Board's reading of the notice --

21 MS. LIU: I do.

22 CHAIRPERSON MILLER: -- into the

1 record? All right. Good.

2 So, Ms. Phillips, do we have any  
3 preliminary matters?

4 MS. PHILLIPS: We do, indeed,  
5 Madam Chair. It's my understanding the  
6 parties have an offer in compromise to present  
7 to the Board. It looks like \$750 is the fine.

8 MS. LIU: I believe so, yes.

9 MS. PHILLIPS: Yes. It's --  
10 writing is sometimes an issue. To be paid in  
11 30 days.

12 CHAIRPERSON MILLER: Okay. Ms.  
13 Liu, do you agree to that offer in compromise  
14 of \$750 to be paid in 30 days?

15 MS. LIU: Yes.

16 CHAIRPERSON MILLER: And do you  
17 understand you waive your right to a hearing  
18 by accepting this offer in compromise?

19 MS. LIU: Yes.

20 CHAIRPERSON MILLER: Okay. Are  
21 there any Board questions? All right.

22 I would then move that we accept

1 this offer in compromise of a penalty of \$750  
2 to be paid within 30 days.

3 Do I have a second?

4 MEMBER BROOKS: Second.

5 CHAIRPERSON MILLER: Mr. Brooks  
6 has seconded the motion.

7 All those in favor say aye.

8 MEMBER BROOKS: Aye.

9 CHAIRPERSON MILLER: Aye.

10 MEMBER SILVERSTEIN: Aye.

11 CHAIRPERSON MILLER: All those  
12 opposed?

13 MEMBER JONES: Opposed.

14 CHAIRPERSON MILLER: All those  
15 abstaining? Then the vote is 3-1-0 to accept  
16 the offer in compromise.
