CHAIRPERSON MILLER: The next case is Case No. 13-AUD-00056, Tackle Box located at 3245 M Street, N.W., License No. 84952, in ANC-2E.

1 MR. UMBEL: Yes, ma'am.

2 CHAIRPERSON MILLER: Okay. Are
3 there any Board questions on this offer?

4 MEMBER ALBERTI: Maybe this has
5 been asked. Is the licensee up to date with
6 the quarterly reports that are due?

7 MR. UMBEL: Yes, I am, yes.

8 MEMBER ALBERTI: You filed this
9 one?

10 MR. UMBEL: Correct. Yes.

11 MEMBER ALBERTI: Okay. Thank you.

12 CHAIRPERSON MILLER: Good
13 question, yeah. Do you know when you filed

15 MR. UMBEL: It was right around
16 the deadline date. I think the 1st or the 2nd,
17 right around the -- I think it was due the 1st
18 electronically. I don't know the stamp, but
19 it was right around that time.
