CHAIRPERSON MILLER: Ms. Phillips,
let's see, there was one case that we passed.

MS. PHILLIPS: We haven't finished
the calendar on statuses. I have one more on
here.

CHAIRPERSON MILLER: Oh, you do?

MS. PHILLIPS: I'm missing, Tattoo
maybe?

CHAIRPERSON MILLER: Okay. Let me
get it. Anyway, they have not appeared yet.

MS. PHILLIPS: Page 4?

CHAIRPERSON MILLER: Yes, Tattoo.
We'll go to Tattoo. Just checking to see if
they have come in.

MS. PHILLIPS: And I would like a
few minutes after the status, so I can see if
we can't reach an agreement.

CHAIRPERSON MILLER: All right.
We do --

MS. PHILLIPS: I couldn't do it --

1 CHAIRPERSON MILLER: We have a
2 Fact-Finding Hearing.

3 MS. PHILLIPS: That's what I
4 thought.

5 CHAIRPERSON MILLER: Okay. All
6 right. Okay. Case No. 12-CMP-00391, Tattoo
7 located at 1413 K Street, N.W., License No.
8 75156 in ANC-2F.

9 MS. PHILLIPS: Louise Phillips,
10 Assistant Attorney General for the District of
11 Columbia.

12 MR. MPRAS: Emanuel Mpras for
13 Tattoo Bar.

14 MR. BATCHELOR: Hi, and Joel
15 Batchelor also for Tattoo Bar.

16 CHAIRPERSON MILLER: And I'm
17 sorry, what's your name, sir?

18 MR. BATCHELOR: It's Joel
19 Batchelor.

20 CHAIRPERSON MILLER: Okay. And
21 what's your position?

22 MR. BATCHELOR: I'm general

1 manager.

2 CHAIRPERSON MILLER: General

3 manager. Okay.

4 MR. MPRAS: Madam Chair, I have a
5 letter authorizing Mr. Batchelor to represent
6 Tattoo Bar. May I approach?

7 CHAIRPERSON MILLER: Yes. Well,
8 Ms. Walker will get it from you. Thank you.
9 Okay. We can proceed.

10 Mr. Mpras, did your client receive
11 notice of this hearing?

12 MR. MPRAS: Yes, ma'am. My client
13 received notice, has read the notice,
14 understands the notice and waives reading
15 thereof.

16 CHAIRPERSON MILLER: Great. Thank
17 you. And, Ms. Phillips, do we have any
18 preliminary matters?

19 MS. PHILLIPS: Indeed we do, Madam
20 Chair. This -- the parties have reached an
21 offer in compromise to present to the Board
22 for approval. It's a fine of \$1,500 to be

1 paid in 60 days.

2 MR. MPRAS: Madam Chair, that is
3 correct.

4 CHAIRPERSON MILLER: Okay. Okay.
5 Any questions by Board Members? Then we have
6 an offer in compromise before us for the Board
7 to consider and I move that we approve this
8 offer in compromise of a fine of \$1,500 to be
9 paid in 60 days.

10 Do I have a second?

11 MEMBER BROOKS: Second.

12 CHAIRPERSON MILLER: Mr. Brooks
13 has seconded the motion.

14 All those in favor say aye.

15 MEMBER ALBERTI: Ms. Miller,
16 before we proceed, I want to make sure that we
17 have on the record that the licensee
18 understands and accepts the offer in
19 compromise and waives his right to a hearing.

20 MS. PHILLIPS: I thought we did
21 that already.

22 MEMBER ALBERTI: Did we do that?

1 MR. MPRAS: I just acknowledged
2 that -- I did acknowledge --

3 MEMBER ALBERTI: Oh, you did
4 acknowledge?

5 CHAIRPERSON MILLER: Yes, Mr.
6 Mpras did.

7 MEMBER ALBERTI: Oh, I missed
8 that. You said it so quickly, Mr. Mpras, I
9 just didn't --

10 MS. PHILLIPS: He doesn't allow
11 questions. He just states it.

12 MR. MPRAS: I just try and get it
13 out.

14 MEMBER ALBERTI: All right. All
15 right. Great. Thank you.

16 MS. PHILLIPS: Several attorneys
17 do that.

18 MEMBER ALBERTI: I didn't hear the
19 question and I apologize. I skipped a beat.
20 Excuse me.

21 CHAIRPERSON MILLER: Okay. Are
22 you satisfied?

1 MEMBER ALBERTI: Yes.

2 CHAIRPERSON MILLER: Okay. Any
3 other questions or concerns?

4 All right. Then there is a motion
5 that has been seconded to approve an offer in
6 compromise of \$1,500 payable in 60 days, to be
7 paid in 60 days or within 60 days. Okay.

8 All those in favor say aye.

9 ALL: Aye.

10 CHAIRPERSON MILLER: All those
11 opposed? All those abstaining? Then the vote
12 is 4-0-0 to accept the offer in compromise.

13 MR. MPRAS: Thank you.

14 CHAIRPERSON MILLER: Thank you
15 very much.

16 (Whereupon, the Show Cause
17 (Status) Hearing in the above-entitled matter
18 was concluded at 10:05 a.m.)
