CHAIR MILLER: The next case on the calendar is Number 11-251-00266, Mio Restaurant at 1110 Vermont Avenue, N.W., License Number 76072 in ANC 2F.

MR. RIVERO: Good morning, Board Members. Fernando Rivero for the District of Columbia standing in for Maureen Zaniel.

CHAIR MILLER: Good morning.

MR. HORWITZ: Good morning. My name is Ely Horwitz. I'm an attorney representing Mio Restaurant and with me is Manuel Iguina.

MR. IGUINA: Manuel Iguina, Licensee.

MR. HORWITZ: Owner of the business.

CHAIR MILLER: Okay. Manuel Iguina, you're the managing member. Is that correct?

MR. IGUINA: Yes, ma'am.

17 compromise to present to the Board at this  
18 time and that offer in compromise consists of  
19 a fine of \$1,500 payable within 60 days and a  
20 one-day suspension of the license to be served  
21 on Saturday, May 26. That's the offer in  
22 compromise.

1 CHAIR MILLER: Okay. And I want  
2 to ask the Licensee is that your understanding  
3 of the offer in compromise? A fine \$1,500  
4 payable within 60 days with a one-day  
5 suspension of the license to be served on  
6 Saturday, May 26?

7 MR. IGUINA: Yes, ma'am.

8 CHAIR MILLER: Okay. Okay. I  
9 would recommend that we accept this offer in  
10 compromise and move accordingly to accept the  
11 offer in compromise of \$1500 payable in 60  
12 days, one-day suspension to be served on  
13 Saturday, May 26.

14 Do I have a second?

15 MEMBER MOBLEY: I second.

16 CHAIR MILLER: Any comments? All  
17 those in favor say aye.

18 (Ayes.)

19 CHAIR MILLER: All those opposed.  
20 All those abstaining. The vote is 5 to 0 to
