CHAIR MILLER: Is everybody ready to turn to the agenda?

MEMBER MOBLEY: Yes.

CHAIR MILLER: Okay. First item on the agenda is a review of manager's application for Michael R. Stone. I'm of the position that I would be interested in a short fact finding hearing to meet this individual.

Do others have comments?

MEMBER ALBERTI: Madam Chair, I'd like to move that we approve this license.

CHAIR MILLER: And is there a second?

MEMBER BROOKS: Second.

CHAIR MILLER: And are there any other comments to the motion that's before us to approve the application?

Not hearing any, all those in favor say aye.

(Ayes.)

1 CHAIR MILLER: All those opposed.  
2 Opposed.

3 MEMBER NOPHLIN: No.

4 CHAIR MILLER: All those  
5 abstaining.

6 MEMBER MOBLEY: Abstain.

7 CHAIR MILLER: So, that is one,  
8 two, three. That's three -- three in favor of  
9 granting the motion to approve, two opposed  
10 and one abstaining.

11 Is that a majority?

12 MEMBER ALBERTI: Well, we have one  
13 abstention. So, that doesn't count. It's  
14 three to two. Three to two.

15 CHAIR MILLER: Oh, I'm sorry.  
16 It's three to two. Okay. The vote is --  
17 well, the vote is 3 to 2 to grant the  
18 application.

19 I'm sorry.

20 Okay. The next two items are  
21 related. Number 2 is a review of a letter  
22 from Bernard Dietz on behalf of Puneeta Singh

1 a judgment creditor of Dupont Wine & Spirits,  
2 LLC and that restaurant's located at 1325  
3 Connecticut Avenue, N.W. and it's requesting  
4 an order granting said client permission to  
5 remove the inventory from the business  
6 premises and store or dispose of the  
7 inventory. Located in 2B.

8 Number 3 is a review of an email  
9 from Andrew Kline on behalf of Raj Mallick and  
10 Theadora Mallick who are the landlords of  
11 1325 Connecticut Avenue, N.W. requesting  
12 reinstatement of a disposal permit previously  
13 issued on October 14, 2011 so that the  
14 landlords can transfer the inventory of the  
15 previous license-holder to the new licensee.

16 I think this is one that I would  
17 suggest that -- two related to one case that  
18 I would suggest that we postpone for one week.

19 Okay. Number 5 is a review of  
20 change of hours application to change the  
21 hours of operation and hours of alcoholic  
22 beverage sales and consumption, Sunday through

1 Thursday 7:00 a.m. to 8:00 p.m., Friday and  
2 Saturday 7:00 a.m. to 12:00 a.m. The current  
3 hours of alcoholic beverage sales and  
4 consumption are Sunday 10:00 a.m. to 8:00  
5 p.m., Monday through Thursday 8:00 a.m. to  
6 8:00 p.m., Friday and Saturday 8:00 a.m. to  
7 12:00 a.m. and the proposed hours are Sunday  
8 10:00 a.m. to 2:00 a.m., Monday through  
9 Thursday 7:00 a.m. to 2:00 a.m., Friday and  
10 Saturday 7:00 a.m. to 3:00 a.m. and proposed  
11 hours of alcoholic beverage sales and  
12 consumption from Sunday 10:00 a.m. to 2:00  
13 a.m., Monday through Thursday 8:00 a.m. to  
14 2:00 a.m., Friday and Saturday 8:00 a.m. to  
15 3:00 a.m. This is Keren Restaurant, 1780  
16 Florida Avenue, N.W. and License Number 88512.

17 It seems that there is a big  
18 change from closing hours from 8:00 p.m. to  
19 2:00 a.m. certainly.

20 So, I would recommend that we  
21 placard this one.

22 Any comments?

1                   So, I would move that we placard  
2                   for the change and all those in -- did I say  
3                   the second?

4                   MEMBER MOBLEY:    Second.

5                   CHAIR MILLER:    Okay.  All those in  
6                   favor say aye.

7                   (Ayes.)

8                   CHAIR MILLER:    All those opposed.  
9                   All those abstaining.  Okay.  The motion  
10                  passes 6 to 0.

11                  Number 6 on the agenda is a review  
12                  of entertainment endorsement application to  
13                  include entertainment.  This is for the Keren  
14                  Restaurant, 1780 Florida Restaurant, N.W.,  
15                  License Number -- I'm sorry.  Did we just do  
16                  that one?  Sorry.

17                  Oh, we had six.  Okay.  The same  
18                  thing.  Right.  That's right.  Okay.  It's the  
19                  same restaurant.  That's the issue.  Okay.

20                  So, I would suggest that we  
21                  placard that as well.

22                  So, I'd move to placard.  Do I

1 have a second?

2 MEMBER SILVERSTEIN: Second.

3 CHAIR MILLER: All those in favor  
4 say aye.

5 (Ayes.)

6 CHAIR MILLER: All those opposed.

7 All those abstaining. The vote passes 6 to 0.

8 Number 7 review of letter dated  
9 February 10, 2012 from Commissioner Kent Boese  
10 of ANC 1A requesting that a protest hearing  
11 for Aman Liquor Store be postponed until after  
12 the Board order is issued for King's Deli and  
13 Grocery.

14 The Board has rescheduled this  
15 matter already for May 2nd at 3:00 p.m. So,  
16 I move that we grant the request. Do I have  
17 a second?

18 MEMBER MOBLEY: Second.

19 CHAIR MILLER: All those in favor  
20 say aye.

21 (Ayes.)

22 CHAIR MILLER: All those opposed.

1 All those abstaining. The vote is 6 to 0.

2 Next is we have a review of a  
3 voluntary agreement dated February 8th, 2012  
4 between El Tamarindo, ANC 2B and ANC 1C and  
5 the Kalorama Citizens Association. El  
6 Tamarindo Adam Morgan is located 1785 Florida  
7 Avenue, N.W., License Number 71179.

8 I would move that we approve this  
9 voluntary agreement. Do I have a second?

10 MEMBER BROOKS: Second.

11 CHAIR MILLER: Any comments? All  
12 those in favor say aye.

13 (Ayes.)

14 CHAIR MILLER: All those opposed.  
15 All those abstaining. The vote is 6 to 0 to  
16 approve.

17 Moving on to Number 9. Review of  
18 a voluntary agreement dated February 3, 2012  
19 between Sushi Sai and ANC 3F. Sushi Sai is  
20 located at 4221 Connecticut Avenue, N.W. It's  
21 License Number 88557.

22 I would move that we approve this

1 voluntary agreement with modification to  
2 Section 12 second sentence. Do I have a  
3 second?

4 MEMBER BROOKS: Second.

5 CHAIR MILLER: Any comments? All  
6 those in favor say aye.

7 (Ayes.)

8 CHAIR MILLER: All those opposed.  
9 All those abstaining. The vote passes 6 to 0.

10 Number 10 is a review of voluntary  
11 agreement dated February 8, 2012 between The  
12 Pinch and ANC 1A. The Pinch is located at  
13 3548 14th Street, N.W., License Number 88333.

14 I would move that we approve the  
15 modification to Section 217. Do I have a  
16 second?

17 MEMBER BROOKS: Second.

18 CHAIR MILLER: Comments?

19 MEMBER ALBERTI: Madam Chair, the  
20 motion is that we approve of the modification?

21 CHAIR MILLER: Yes.

22 MEMBER ALBERTI: Okay. Thank you.

1 I didn't -- I misunderstood. Yes, that's  
2 fine.

3 CHAIR MILLER: Okay. All those in  
4 favor say aye.

5 (Ayes.)

6 CHAIR MILLER: All those opposed.  
7 All those abstaining. The motion passes 6 to  
8 0 to approve with modification.

9 Eleven is the review of voluntary  
10 agreement dated February 13th, 2012 between  
11 The Guitar Bar and ANC 2B. The Guitar Bar is  
12 located at 1216 18th Street, N.W.. It's  
13 License Number is 86903.

14 I would move that we approve this  
15 voluntary agreement with modification to  
16 Section 3A. Do I have a second?

17 MEMBER BROOKS: Second.

18 CHAIR MILLER: Any comments? All  
19 those in favor say aye.

20 (Ayes.)

21 CHAIR MILLER: All those opposed.  
22 All those abstaining and the motion passes to

1 approve the modification by a vote of 6 to 0.

2 Now, I believe we also have a  
3 supplement agenda.

4 The first item on that agenda is  
5 review of a request from the Licensee for  
6 approval of stipulated license and letter of  
7 support from ANC 6A. The restaurant is Souk  
8 Restaurant located 1208 H Street, N.E.,  
9 License Number 88675.

10 I would move that we postpone  
11 consideration of this request for a week.

12 MEMBER MOBLEY: I second.

13 CHAIR MILLER: Okay. All those in  
14 favor say aye.

15 (Ayes.)

16 CHAIR MILLER: All those opposed.  
17 All those abstaining. The vote passes 6 to 0.

18 Number 2 on this supplemental  
19 agenda is the review of an email dated  
20 February 21st, 2012 asking if Fasil Ethiopian  
21 Restaurant can sell product if its LLC charter  
22 was revoked by DCRA. This is related to Fasil

1 Ethiopian Restaurant, 1608 7th Street, N.W.,  
2 License Number 81849.

3 My understanding is that the Board  
4 has issued a cease and desist order with  
5 respect to this case and no further action  
6 would be required at this time.

7 And I think that concludes our  
8 agenda and supplementary agenda for February  
9 22nd, 2012 and I don't believe there is  
10 anything further on the agenda for this  
11 afternoon.

12 So, I will read our closing  
13 instructions unless anyone has anything else  
14 to add to today's agenda.

15 Okay. As Chairperson of the  
16 Alcoholic Beverage Control Board for the  
17 District of Columbia and in accordance with  
18 Section 405 of the Open Meetings Amendment Act
