CHAIRPERSON MILLER: Okay, the next case on our calendar is Case No. 12-CMP-00326, Phillips Flagship, located at 900 Water Street, SW, License No. 9229, in ANC 6D.

19 MS. SELLERS: Yes, we read it and  
20 understood it.

21 CHAIRPERSON MILLER: And, do you

5 Ms. Gephardt?

11 within 30 days.

12 CHAIRPERSON MILLER: Okay. Ms.  
13 Sellers, is that what -- does your client  
14 agree to this offer in compromise? I'm just  
15 going to repeat it, \$2,000 fine, to be paid  
16 within 30 days.

17 MS. SELLERS: Yes, that's correct.

18 CHAIRPERSON MILLER: Okay. Any  
19 questions by Board Members?

20 All right. I would move then that  
21 we approve this offer in compromise of a fine  
22 of \$2,000, to be paid within 30 days.
