CHAIRPERSON MILLER: The next case on our calendar is Case No. 12-CMP-00597, Chief Ike's Mambo Room located at 1723 Columbia Road, N.W., License No. 17940 in ANC-1C.

Will the parties in this case, please, come forward and take a seat at the table?

MR. JIRIKOWIC: Good morning.

CHAIRPERSON MILLER: Good morning.

MR. STERN: Michael Stern representing the District of Columbia.

13 notes a Mr. Gherrey as president, G-H --

14 MR. JIRIKOWIC: Gherrey. He is --  
15 yes, my partner.

16 CHAIRPERSON MILLER: Okay. So you  
17 are co-owners?

18 MR. JIRIKOWIC: Yes.

19 CHAIRPERSON MILLER: And can you  
20 just tell us what percentage you own?

21 MR. JIRIKOWIC: Half.

22 CHAIRPERSON MILLER: Half, okay.
