CHAIRPERSON MILLER: The next case on our calendar is Case No. 12-CMP-00488, Corina's Restaurant located at 831 Kennedy Street, N.W., License No. 79873 in ANC-4D.

Would the parties in this case, please, come forward? Good morning.

MS. GARAY: Good morning. Sylvia Garay, restaurant owner of Corina's Corporation.

CHAIRPERSON MILLER: Okay. And would you also sign-in, please, and put your name?

MS. GEPHARDT: Chrissy Gephardt on behalf of the Office of the Attorney General.

CHAIRPERSON MILLER: Okay. Thank you. Ms. Garay, I want to ask you, did you receive notice of this hearing?

MS. GARAY: Yes.

CHAIRPERSON MILLER: And did you read it and understand it?

1 MS. GARAY: Yes.

2 CHAIRPERSON MILLER: Okay. Then
3 I'm going to enter that notice into the
4 record, unless there is any objections. Okay.

5 Are there any preliminary matters
6 in this case, Ms. Gephardt?

7 MS. GEPHARDT: Yes, there is. In
8 this case, the parties have agreed on an offer
9 in compromise. The offer would be a \$350 fine
10 to be payable within 30 days.

11 CHAIRPERSON MILLER: Okay. Ms.
12 Garay, I just want to confirm that you do
13 agree to that offer in compromise of \$350 to
14 be paid within 30 days?

15 MS. GARAY: Yes.

16 CHAIRPERSON MILLER: Okay. And
17 you understand you waive your right to a
18 hearing if you accept this offer in
19 compromise?

20 MS. GARAY: Yes.

21 CHAIRPERSON MILLER: Okay. Other
22 questions by Board Members?

1 Okay. Not hearing any, then I
2 move that we accept this offer in compromise
3 of a fine of \$350 payable within 30 days.

4 Do I have a second?

5 MEMBER BROOKS: I'll second it.

6 CHAIRPERSON MILLER: Mr. Brooks
7 has seconded the motion.

8 All those in favor say aye.

9 MEMBER ALBERTI: Aye.

10 CHAIRPERSON MILLER: Aye.

11 MEMBER BROOKS: Aye.

12 MEMBER SILVERSTEIN: Aye.

13 CHAIRPERSON MILLER: All those
14 opposed? All those abstaining?

15 MEMBER JONES: Abstain.

16 CHAIRPERSON MILLER: Then the vote
17 is 4-0-1. The motion passes to approve the
18 offer in compromise.

19 Okay. Thank you very much.
