CHAIRPERSON MILLER: This bring us to the case at-hand. I'm sorry that we kept you waiting. Our previous case went longer than expected.

All right. I'm going to call a Fact-Finding Hearing in Case No. 12-251-00370, Indulj located at 1208 U Street, N.W., License No. 079843 in ANC-1B.

Okay. Would you identify yourselves for the record, when you are ready?

MR. KLINE: Yes. Good afternoon, Madam Chair. Andrew Kline on behalf of the licensee seated to my left, Garnell Wilson.

CHAIRPERSON MILLER: Okay. So this is -- really should be pretty short. It's just a status. We want an update from where we left off. And is our investigator still here? Okay. Here he comes.

MEMBER BROOKS: By the flag.

CHAIRPERSON MILLER: Okay. Would

1 you introduce yourself for the record, please?

2 INVESTIGATOR JONES: I'm
3 Investigator Earl Jones with ABRA.

4 CHAIRPERSON MILLER: Okay.
5 Welcome. So I was saying that I expect this
6 should be fairly short. It's just an update
7 of what has happened since we last saw you.

8 There was an issue with cameras
9 and then there was an issue with respect to
10 neighbors who had raised concerns about being
11 fearful in front of your establishment.

12 And apparently no neighbors have
13 come, even though this case is going on a
14 little later, they weren't here at the
15 scheduled time either.

16 So whoever wants to go first can.

17 MR. KLINE: Yes.

18 CHAIRPERSON MILLER: Okay.

19 MR. KLINE: In addition to that, I
20 was not here for the original fact-finding
21 hearing. Mr. Rome of the Veritas Law Firm was
22 here, but I have read the transcript.

1 CHAIRPERSON MILLER: Okay.

2 MR. KLINE: And, yes, I think the
3 Board raised those concerns.

4 Mr. Wilson did attempt on his own
5 to arrange a meeting with the community, sent
6 out notice and showed up, but he remains
7 prepared to engage with the community and work
8 with the community with respect to whatever
9 concerns they might have specifically
10 concerning his establishment.

11 In addition, I do have a handout
12 with respect to the security system, which
13 shows where the cameras are located. There
14 are actually color photographs labeled each
15 camera. And in the front of the handout is a
16 shot of the monitor, which shows the views
17 from the 16 cameras that are there. And I
18 would be happy to make that available to the
19 Board.

20 CHAIRPERSON MILLER: Thank you.

21 MR. KLINE: And those are the only
22 two issues that I saw in the transcript.

1 CHAIRPERSON MILLER: Um-hum.

2 MR. KLINE: We are happy, of
3 course, to address whatever other questions or
4 concerns the Board might have concerning Mr.
5 Wilson's operations at this location.

6 CHAIRPERSON MILLER: Okay. Mr.
7 Jones, do you have something you want to say
8 about the establishment and their compliance
9 with the security? They just put in cameras
10 and also anything with respect to the
11 neighbors, that were the two issues?

12 INVESTIGATOR JONES: Well, I --
13 well, first, good afternoon to the Board.

14 I know from our last hearing that
15 there were several neighbors that were here
16 that raised concern.

17 CHAIRPERSON MILLER: Right.

18 INVESTIGATOR JONES: I will
19 confirm that I also got an invitation to Mr.
20 Wilson's meeting that was supposed to be held
21 at the establishment. However, I was on days
22 and wasn't able to attend. But I do recall

1 that meeting. I wasn't aware of who showed up
2 or who didn't show up, but I know that he did
3 attempt to have that meeting.

4 And I know that from our last
5 hearing here, the Fact-Finding Hearing that he
6 and I spoke, and, you know, I told him that,
7 you know, that would be a good thing to do is
8 to try to coexist in peace with the neighbors
9 and try to figure out ways to try to, you
10 know, eliminate some of the issues that they
11 are having, whatever you can do.

12 So I will confirm that he did do
13 that.

14 As far as the cameras and the
15 follow-up to the hearing, I visited the
16 establishment last night and Mr. Wilson did
17 have all 16 cameras in operation. He actually
18 added extra cameras on to -- there is a rear
19 patio area on the second level that he added
20 extra cameras to.

21 And to be honest with you,
22 unfortunately, he had a mishap where he had

1 vandals come in and actually steal some of his
2 equipment, so he actually had the cameras
3 before and replaced them as well.

4 So as far as I'm concerned, I have
5 determined that it seems that he has followed
6 everything that he was supposed to do within
7 realms of his security plan and what the Board
8 has asked.

9 CHAIRPERSON MILLER: Okay. Thank
10 you. Any questions? Okay. Well, thank you.

11 MR. KLINE: Thank you.

12 CHAIRPERSON MILLER: You have
13 answered all of our questions now or concerns.
14 So have a good afternoon.

15 MR. KLINE: Thank you.

16 CHAIRPERSON MILLER: What's left
17 of it. Yes, okay.

18 INVESTIGATOR JONES: Thank you,
19 Chair.

20 MEMBER ALBERTI: Investigator
21 Jones, thank you.

22 INVESTIGATOR JONES: Yes, sir.

1 MEMBER ALBERTI: Just thank you.

2 INVESTIGATOR JONES: Oh, thank
3 you, sir.

4 MEMBER ALBERTI: Appreciate it.

5 INVESTIGATOR JONES: Have a good
6 day.

7 CHAIRPERSON MILLER: Thank you.

8 MEMBER ALBERTI: Thank you.

9 MR. KLINE: Same to you. Thank
10 you.

11 (Whereupon, the Fact-Finding
12 (Status) Hearing in the above-entitled matter
13 was concluded at 3:56 p.m.)
