9 3:00 am. The proposed hours of operation
10 would be 11:00 am to 4:00 am. No change in
11 proposed hours of alcoholic beverage sales/
12 service. And there is no pending
13 investigative matters or enforcement matters.

14 Okay. This is for Lace, 2214
15 Rhode Island Avenue, N.E., License No. 76369.

16 And I would move that we hold a
17 Fact-Finding on this application.

18 MEMBER SILVERSTEIN: Second.

19 CHAIRPERSON MILLER: Mr.
20 Silverstein seconded the motion.

21 All those in favor say aye.

22 ALL: Aye.

1 CHAIRPERSON MILLER: All those
2 opposed? All those abstaining? The vote is
3 to approve 3-0-0 for a Fact-Finding.

6 I move that we approve this

7 They propose hours of live
8 entertainment would be Sunday through Thursday
9 6:00 pm to 2:00 am and Friday and Saturday
10 6:00 pm to 3:00 am.

11 Okay. I move that we placard this
12 endorsement application. Do I have a second?

13 MEMBER BROOKS: Second.

14 CHAIRPERSON MILLER: Mr. Brooks
15 has seconded the motion.

16 All those in favor say aye.

17 ALL: Aye.

18 CHAIRPERSON MILLER: All those
19 opposed? All those abstaining? Then the vote
20 is 3-0-0 to placard. And this is for Twelve
21 Restaurant & Lounge located at 1123 H Street,
22 N.E, License No. 76366.
