CHAIRPERSON MILLER: Okay. The next case on our calendar is a Show Cause (Status) Hearing, Case No. 13-AUD-00016, Medaterra located at 2614 Connecticut Avenue, N.W., License No. 26206, in ANC-3C.

MR. RIVERO: Good morning, Board Members. Fernando Rivero for the District of Columbia.

10 \$2,000 payable within 60 days. Do I have a

13 CHAIRPERSON MILLER: Mr. Rodriguez
