CHAIRPERSON MILLER: Next case on our calendar is Case No. 12-CMP-00458, Ruby Tuesday #5320 located at 3365 14th Street, N.W., License No. 75456 in ANC 1A.

MS. SCHMIDT: Good morning. Amy Schmidt, Assistant Attorney General on behalf of the District of Columbia.

18 be paid today.

21 MS. SCHMIDT: Five hundred dollars
22 to be paid today.

1 CHAIRPERSON MILLER: Okay. Mr.
2 Farmer, is it your client's understanding that
3 the OIC is for \$500 to be paid today?

4 MR. FARMER: Yes, it is.

5 CHAIRPERSON MILLER: And also that
6 by accepting this OIC the establishment waives
7 its right to a hearing?

8 MR. FARMER: Yes.

9 CHAIRPERSON MILLER: Okay. Any
10 questions by Board Members?

11 (No audible response.)

12 CHAIRPERSON MILLER: Okay. Not
13 hearing any, I move that the Board accept this
14 Offer in Compromise of \$500 to be paid today.
15 Do I have a second?

16 MEMBER BROOKS: Second.
