3 CHAIRPERSON MILLER: The next Show  
4 Cause Hearing (Status) case is Case No. 14-CMP-  
5 00739, D & B Deli Carryout. Is anybody here from  
6 that case?

7 MS. ZANIEL: Maureen Zaniel on behalf  
8 of the District of Columbia. We have not heard  
9 from them. I noted yesterday when I was looking  
10 at the file that the Investigator indicated that

5 And we actually have another case in which we  
6 will be having an interpreter there for in  
7 Korean, a Korean interpreter, so that's all set  
8 up for May 6th.

9 MS. ZANIEL: Well, I mean --

11 it.

12 MS. ZANIEL: -- I have no issue with  
13 that. What I have a concern about is --

14 CHAIRPERSON MILLER: Okay.

15 MS. ZANIEL: -- whether they have  
16 understood and will understand --

17 CHAIRPERSON MILLER: The notice?

18 MS. ZANIEL: -- correct.

19 CHAIRPERSON MILLER: Okay.

20 MS. ZANIEL: You know, I have no  
21 information as to why they are not here today.

22 CHAIRPERSON MILLER: Right. Okay.

1       Okay. All right. So we will look into that  
2       issue as well.
