CHAIRPERSON MILLER: The next case is another Protest (Status) Hearing case. It's Case No. 14-PRO-00013, Bill Bison Lounge located at 2718 Georgia Avenue, N.W., License No. 14759, in ANC-1B. And this is a renewal application. Good morning.

MR. GARY: Good morning.

CHAIRPERSON MILLER: When you are ready, if you would introduce yourself for the record?

MS. MITCHELL: I'm Carolyn Mitchell, assistant with Chuck and Bill Bison Lounge.

MR. GARY: I'm Charles Gary, the owner.

CHAIRPERSON MILLER: You're the owner. Okay. Good morning. And over here?

6 scheduled for June 4, 2014 at 4:30 p.m. I'll
7 highlight a few things.

8 The purpose of a Protest Hearing
9 is to determine the appropriateness of the
10 establishment in the section of the District
11 where the establishment is located. What is
12 most important is you should be getting a
13 Protest Information and an Exhibit Form in
14 which you need to file and serve on the
15 opposing party within seven days of the
16 hearing, these forms, and they are very
17 important.

18 And if you don't file them, it's
19 possible that your case could be dismissed or
20 your witness or your exhibit might not be
21 allowed. The purpose is to inform the Board
22 and the other party exactly who your witnesses

1 are, what your exhibits are, that we don't
2 want any surprises and then we have a focus at
3 the hearing and it moves smoothly that way.

4 So if you have any questions about
5 that between now and the hearing, feel free to
6 ask Ms. Jenkins or Ms. Anderson. Ms.
7 Anderson's number is 442-6492. Any questions?

8 MR. TURNER: No.

9 CHAIRPERSON MILLER: Okay.

10 MR. TURNER: We did have mediation
11 last week.

12 CHAIRPERSON MILLER: Okay.

13 MR. TURNER: And I anticipate the
14 Board will not see him in June.

15 CHAIRPERSON MILLER: Great. Okay.
16 Well, just in case. Okay. Thank you. That
17 concludes this case.
