CHAIRPERSON MILLER: The next case is Case No. 13-AUD-00031, The Ugly Mug Dining Saloon located at 723 8th Street, S.E., in ANC-6B.

MS. PHILLIPS: Louise Phillips, Assistant Attorney General for the District of Columbia.

MR. JABLONSKI: Gaynor Jablonski, owner of The Ugly Mug.

CHAIRPERSON MILLER: Good morning.

MR. JABLONSKI: Good morning.

CHAIRPERSON MILLER: Mr. Jablonski, did you receive notice of this hearing?

MR. JABLONSKI: I did.

CHAIRPERSON MILLER: Did you read it and understand it?

MR. JABLONSKI: I did.

15 for failure to pay the original fine, which
16 has now been paid.

18 MS. PHILLIPS: And he will pay it
19 today.

20 MEMBER RODRIGUEZ: Okay.

21 CHAIRPERSON MILLER: Okay. Good.
22 So let me just get you on the record, Mr.

1 Jablonski. Do you agree to the offer in
2 compromise of a fine of \$1,000 payable today?

3 MR. JABLONSKI: Yes.

4 CHAIRPERSON MILLER: And do you
5 understand you waive your right to a hearing
6 by entering into this offer in compromise?

7 MR. JABLONSKI: Yes.

8 CHAIRPERSON MILLER: Okay. Any
9 questions by Board Members? Okay. Then I
10 move that we accept this offer in compromise
11 of \$1,000 payable today. Do I have a second?

12 MEMBER RODRIGUEZ: Second.

13 CHAIRPERSON MILLER: Mr. Rodriguez
14 has seconded the motion.

15 All those in favor say aye.

16 ALL: Aye.

17 CHAIRPERSON MILLER: All those
18 opposed? All those abstaining? The motion
19 passes 6-0-0.
