CHAIRPERSON MILLER: The next case on our calendar is Case No. 12-CMP-00712, District Liquors located at 1211 11th Street, N.W.

Is anybody here from District Liquors? Good morning.

MR. KIM: Yes, good morning.

CHAIRPERSON MILLER: Have a seat. If you could sign-in, yes. And then when ready if the parties could introduce themselves for the record?

MS. PHILLIPS: Louise Phillips, Assistant Attorney General, for the District of Columbia.

CHAIRPERSON MILLER: Okay. You are the president?

MR. KIM: Yes, ma'am.
