3 MR. RIVERO: We would like to recall
4 the case that was set for 10 o'clock.

5 CHAIR MILLER: Okay.

6 MEMBER ALBERTI: Thank you very much.

7 MR. RIVERO: Okay. And we simply
8 would like to revise the term, in that case, to
9 reflect 30 rather than 60 days.

10 MEMBER SILVERSTEIN: The 60 days.

11 CHAIR MILLER: Correct.

12 MR. RIVERO: That reaches the
13 understanding that we had of these two cases.
14 That the \$6,000 would be paid in 30 rather than
15 60 days.

16 CHAIR MILLER: Correct. Okay.

17 MEMBER SILVERSTEIN: Madam Chair,
18 having voted in favor of that, I would like to
19 move that we reconsider to recall.

20 CHAIR MILLER: I second that. Okay.
21 So then we're going to re-vote on the first case,
22 in which we said that we approved an Offer in

1 Compromise of \$2,000 for the 60 days.

2 We're now going to vote the Offer in
3 Compromise will be \$2,000 to be paid within 30
4 days. And this is for case Number 13-CMP-00289.

5 So I make a motion that we approve the
6 Offer in Compromise as amended now for \$2,000
7 penalty paid within 30 days. If not paid within
8 30 days, then the license will be suspended until
9 paid. Do I have a second?

10 MEMBER SHORT: What is that motion
11 again, Madam Chair? I didn't --

12 CHAIR MILLER: This is for the first
13 case. For the \$2,000 fine. Changing it to have
14 the penalty paid within 30 days as opposed to 60
15 days.

16 MEMBER SHORT: Okay.

17 CHAIR MILLER: And if not paid within
18 30 days, then the license would be suspended
19 until paid.

20 MEMBER SHORT: I second that motion.

21 CHAIR MILLER: All right. Mr. Short
22 seconded the motion. All those in favor say aye?

1 (Chorus of ayes)

2 CHAIR MILLER: All those opposed? All
3 those abstaining? Motion passes 6-0-0.

4 Thank you, Mr. Rivero. Anything else?

5 MR. RIVERO: I understand the Board
6 will issue on both cases?

7 CHAIR MILLER: Correct.

8 MR. RIVERO: Thank you.

9 CHAIR MILLER: Thank you very much.

10 MEMBER SHORT: Thank you.

11 CHAIR MILLER: Thank you, sir. Have
12 a good day. That concludes the morning calendar.
13 And the Board will recess until our next hearing,
14 which is at 1:30 p.m.
