AGENT FLETCHER: Would the parties in the matter of Justin's Cafš please come forward. The parties in the matter of Justin's Cafš.

This is Case Number 13-PRO-00014, Justin's Cafš, LLC, trading as Justin's Cafš. 1025 1st Street, SE, License Number ABRA-083690. This is a Retailer CR application for a license renewal.

The protest issues are adverse impact on peace, order and quiet. My name is La Verne Fletcher and I'll be conducting the roll call hearing as the Board's Agent pursuant to D.C. Official Code 1601.2.

Introductions beginning with the applicant. Is the licensee present in the matter of Justin's Cafš?

Who is present on behalf of ANC-6D.

MS. ROLE: Hello. My name is

1 Susan Eads Role for ANC-6D.

2 AGENT FLETCHER: Thank you, Ms.
3 Role. Is ANC-6D been in communication with
4 the licensee?

5 MS. ROLE: Yes, we have.

6 AGENT FLETCHER: Do you have a
7 settlement agreement?

8 MS. ROLE: We are close to working
9 one out.

10 AGENT FLETCHER: The time is
11 10:03. Justin's CafŠ is not present for the
12 Roll Call Hearing. Therefore, the license
13 renewal application is dismissed.

14 The applicant will have 10 days to
15 seek reinstatement of his application and you
16 may continue to work on your settlement
17 agreement and if you're able to reach a
18 settlement agreement then you may still submit
19 it for Board renew and approval. But for the
20 purpose of the Roll Call Hearing, the license
21 renewal application is dismissed.

22 MS. ROLE: Thank you.

1 AGENT FLETCHER: Ms. Role, did you
2 put your contact information on that sheet?

3 MS. ROLE: No, but I will.

4 AGENT FLETCHER: Okay. Thank you.

5 Thank you very much. The Roll
6 Call Hearing is concluded.

7 (Whereupon, the above matter was
8 concluded at 10:04 a.m. and reopened at 10:11
9 a.m.)

10 AGENT FLETCHER: I'd like to
11 reopen the case of Justin's Cafš. Can we
12 reopen Justin's Cafš for a moment?

13 Okay. I'm reopening the case of
14 Justin's Cafš for just a moment. Ms. Role,
15 thank you for staying. I received a message
16 that Justin's Cafš is running late due to a
17 sink hole on 14th Street and that they will be
18 here any moment and I'll see if that's
19 Justin's Cafš coming into the room right now.

20 Justin's Cafš? Okay. Thank you.

21 Your name for the record, please.

22 MR. ROSS: Justin Ross.

1 MR. ROSS: And, Mr. Ross, would
2 you please spell your name for the Court
3 Reporter?

4 MR. ROSS: J-U-S-T-I-N R-O-S-S.

5 AGENT FLETCHER: Thank you. Mr.
6 Ross, just so that you know before you came
7 and before I received notice that you were
8 running late, I had dismissed your Renewal
9 Application but I retracting that.

10 MR. ROSS: I apologize.

11 AGENT FLETCHER: No problem. I
12 got your note after I had done that. I
13 received a note from the staff that you were
14 running late and so the License Renewal
15 Application is not dismissed.

16 And just since you're here, I'll
17 tell you what happened in your absence. ANC-
18 6D was granted standing as a Protestant. So,
19 what we need to do is set a date for a Status
20 Hearing, a Protest Hearing and we also need to
21 set a date for mediation.

22 MR. ROSS: Okay.

1 AGENT FLETCHER: So, we'll do that
2 now that you're here. Would you also put your
3 contact information on that sheet on the desk.

4 MR. ROSS: Okay.

5 AGENT FLETCHER: The Status
6 Hearing is July the 10th at 9:30 a.m.

7 The date for the Protest Hearing
8 is September the 11th, 2013, at 1:30 p.m.

9 And we need to schedule a date for
10 mediation to occur prior to the Status Hearing
11 so I'm going to give you some dates available
12 for mediation. The first date is available is
13 Friday, June the 14th at 9:00, 10:00, 11:00 or
14 1:00.

15 MR. ROSS: Okay.

16 AGENT FLETCHER: If that's good
17 then we'll make it the 14th. Is that good for
18 you, Mr. Ross?
