AGENT FLETCHER: Would the parties present in the matter of World Liquors please come forward? World Liquors?

MR. LEE: I'm right here.

PARTICIPANT:

AGENT FLETCHER: Thank you. This is Case Number 12-PRO-00046, World Liquors, Inc, trading as World Liquors, 1453 Pennsylvania Avenue, SE, License Number ABRA-000076. This is a Retailer A - License Renewal. The protest issues are adverse impact on peace, order, and quiet.

My name is La Verne Fletcher and I am conducting the Roll Call Hearing as the Board's Agent, pursuant to DC Official Code 1601.2.

Introductions, beginning with the Applicant. Hi, sir, could you please state your name and spell it for the record?

MR. LEE: Sure. My name is

1 Richard, last name is Lee, R-I-C-H-A-R-D
2 L-E-E.

3 AGENT FLETCHER: Thank you, Mr.
4 Lee. You're the Applicant?

5 MR. LEE: Yes.

6 AGENT FLETCHER: Thank you, very
7 much. And on behalf of ANC-6B?

8 MS. GREEN: Carol Green, C-A-R-O-L
9 G-R-E-E-N, Commissioner and ABC Chair of ANC
10 6B.

11 AGENT FLETCHER: Thank you, Ms.
12 Green. ANC-6B is the only Protestant in this
13 matter. ANC-6B does have standing as a
14 Protestant.

15 We need to set a date for
16 mediation, a Status Hearing, and a Protest
17 Hearing. I will give you the dates of the
18 Status and Protest Hearing first. The date
19 for the Status Hearing is July 18, at 9:30
20 a.m. July 18, at 9:30 a.m for the Status.
21 The date for the Protest Hearing is set for
22 October 3, at 4:00 p.m. We need to set a date

1 for mediation to occur prior to July 18.

2 MS. GREEN: Could we do it on the
3 26th at 1:00?

4 AGENT FLETCHER: There's already
5 something on the 26th at 1:00, Ms. Green.

6 MS. GREEN: Oh.

7 AGENT FLETCHER: But we could do
8 something earlier. But it's probably going to
9 be too early for you at 9:00 a.m.?

10 MS. GREEN: Yes. That's too
11 early. How about the 19th at 1:00 a.m.?

12 AGENT FLETCHER: There's already
13 something on the calendar for the 19th at
14 1:00.

15 MS. GREEN: All right. July 3?
16 Mr. Lee would like a Tuesday.

17 MR. LEE: Tuesdays are more
18 convenient for me, that's why.

19 AGENT FLETCHER: Tuesdays?

20 MR. LEE: Les.

21 AGENT FLETCHER: Do you want me to
22 see if there any Tuesdays before July 3 or

1 just go on to July 3?

2 MS. GREEN: July 3? Okay.

3 AGENT FLETCHER: Tuesday, July 3.

4 Let me see something here.

5 MS. GREEN: We need time to
6 resolve this issue before the mediation.

7 AGENT FLETCHER: One o'clock on
8 Tuesday, July 3 is good.

9 MR. LEE: July 3, 1:00?

10 AGENT FLETCHER: Yes. And if you
11 do, there's no mediation, no Status Hearing,
12 and No Protest Hearing, if the Board approves.

13 MS. GREEN: We'll let you know.

14 AGENT FLETCHER: Yes. Let's see,
15 Mr. Lee, did you put your daytime number and
16 e-mail address on that sheet?

17 MR. LEE: Sure.

18 AGENT FLETCHER: Thank you. Okay
19 The Roll Call Hearing is concluded. Thanks
20 for coming.
