This is Case Number 12-PRO-00050, Kartic, Inc., Inc, trading as New York Liquors, 1447 Maryland Avenue NE, License Number ABRA-076234. This a Retailer Class A, Renewal Application. The protest issues are adverse impact on peace, order, and quiet, residential parking, and vehicular and pedestrian safety.
