3 CHAIRPERSON MILLER: Okay. And
4 now, is anybody else here for a Status
5 Hearing, because I called them all, so if no
6 one else is here, then we will move into our
7 Show Cause Hearings.

8 Okay. Thank you. Okay. We have
9 a Show Cause Hearing scheduled for 10:00 and
10 it is now 10:12 and I'm going to call then
11 Case No. 12-CMP-00399, Panda Cafe located at
12 2138 Pennsylvania Avenue, N.W., License No.
13 72312, in ANC-2A.

14 MS. SING: Hi.

15 CHAIRPERSON MILLER: Hi.

16 MR. RIVERO: Good morning, Board
17 Members. Fernando Rivero for the District of
18 Columbia.

19 CHAIRPERSON MILLER: Okay. When
20 you are ready, would you introduce yourself?

21 MS. SING: Uh-huh, yes.

22 CHAIRPERSON MILLER: And who are

1 you? What's your name?

2 MS. SING: Ling Sing.

3 CHAIRPERSON MILLER: Okay. Are
4 you the owner?

5 MS. SING: Uh-huh.

6 CHAIRPERSON MILLER: All right.
7 When you have a chance before you leave, don't
8 forget to sign-in.

9 MS. SING: Okay.

10 CHAIRPERSON MILLER: This is a
11 Show Cause Hearing. Are there any preliminary
12 matters?

13 MR. RIVERO: Yes, the parties have
14 an offer in compromise to present to the
15 Board, at this time.

16 CHAIRPERSON MILLER: Okay.

17 MR. RIVERO: The offer consists of
18 a fine of \$1,500 for Charge 1; a fine of \$350
19 for Charge 2; the dismissal of Charge 3 for a
20 total of \$1,850 fine payable in 30 days.

21 CHAIRPERSON MILLER: Okay. Ms.
22 Sing?

1 MS. SING: Um-hum.

2 CHAIRPERSON MILLER: Do you agree
3 to that offer in compromise of a fine of
4 \$1,850 to be paid within 30 days?

5 MS. SING: Um-hum, yes, I do.

6 CHAIRPERSON MILLER: You do?

7 MS. SING: Um-hum.

8 CHAIRPERSON MILLER: And you
9 understand that you waive your right to a
10 hearing?

11 MS. SING: Yes, I do.

12 CHAIRPERSON MILLER: Okay.

13 MS. SING: Um-hum.

14 CHAIRPERSON MILLER: Any questions
15 by Board Members?

16 Okay. I move that we accept this
17 offer in compromise of \$1,850 to be paid
18 within 30 days.

19 Do I have a second?

20 MEMBER BROOKS: Second.

21 CHAIRPERSON MILLER: Mr. Brooks
22 has seconded the motion.

1 All those in favor say aye.

2 ALL: Aye.

3 CHAIRPERSON MILLER: All those
4 opposed? All those abstaining? The motion
5 passes by a vote of 3-0-0. Okay.

6 MS. SING: Okay.

7 MR. RIVERO: Thank you.

8 MS. SING: Thank you.

9 CHAIRPERSON MILLER: Just wait for
10 your piece of paper and then you can go.
11 Okay. Our next case on the morning calendar
12 is a Show Cause Hearing scheduled for 11:00,
13 that is Casa Blanca Restaurant, so the Board
14 will recess and come back at 11:00. Thank
15 you.
