The Alcoholic Beverage Control Board met in Alcoholic Beverage Control Hearing Room Suite 400S, at 2000 14th Street, N.W., Washington, D.C., LaVerne Fletcher, Agent, presiding.

3 MS. FLETCHER: Would the parties
4 in the matter of Wah Sing Restaurant please
5 come forward? The parties in the matter of
6 Wah Sing Restaurant?

7 This is Case #13-PRO-00080, KYW,
8 Inc., trading as Wah Sing Restaurant, 2521
9 Pennsylvania Avenue, S.E, License #ABRA-
10 000514. This is a Retailer CR License
11 Renewal.

12 The protest issues are adverse
13 impact on peace, order and quiet.

14 Introductions beginning with the
15 Applicant?

16 MR. WONG: My name is Kaichiu
17 Wong. Last name W-O-N-G.

18 MS. FLETCHER: Okay. Can you say
19 that again? What's the first name?

20 MR. WONG: Kaichiu -- K-A-I-C-H-I-
21 U, last name Wong -- W-O-N-G.

22 MS. FLETCHER: The last name is W

1 --

2 MR. WONG: O-N-G.

3 MS. FLETCHER: -- O-N-G. Thank
4 you very much.

5 And your name, sir?

6 MR. LEE: Philip Lee. I'm an
7 interpreter.

8 MS. FLETCHER: Okay. You're the
9 interpreter --

10 MR. LEE: For Mr. Wong.

11 MS. FLETCHER: -- accompanying Mr.
12 Wong?

13 MR. LEE: Yes.

14 MS. FLETCHER: Okay. I'm just
15 making that distinction because ABRA also
16 schedules interpreters. So I'm just making
17 the distinction between Mr. Wong bringing his
18 interpreter and ABRA providing an interpreter.

19 So could you spell your name for
20 me one more time, please?

21 MR. LEE: Yes. Lee -- L-E-E.

22 MS. FLETCHER: Okay.

1 MR. LEE: Then Philip -- P-H-I-L-
2 I-P.

3 MS. FLETCHER: Okay. Thank you.

4 And Mr. Lee, which language will
5 you be translating in?

6 MR. LEE: Chinese.

7 MS. FLETCHER: Chinese. Thank
8 you. Thank you for coming.

9 And for the protestants?

10 MR. RICHARDS: Robert Richards.
11 I'm Chairman of ANC 7B.

12 MS. FLETCHER: Thank you, Mr.
13 Richards.

14 And your name, sir?

15 MR. BUTLER: Gary Butler,
16 Commissioner for 7B.

17 MS. FLETCHER: Thank you.

18 ANC 7B does have standing as a
19 protestant.

20 Do you need to translate for Mr.
21 Wong?

22 MS. FLETCHER: We'll need to set a

1 date for a status hearing and a protest
2 hearing.

3 I'm sorry. You were going to say
4 something, Mr. Butler?

5 MR. RICHARDS: We don't need to
6 set a date for a protest hearing because we've
7 reached a settlement agreement with the
8 restaurant which we have here. And so, we'd
9 like to present that at this time.

10 MS. FLETCHER: I'll take that.
11 Thank you. Please disregard. Thank you very
12 much.

13 Mr. Richards has just provided me
14 with a settlement agreement entered into
15 between ANC 7B and the licensee. Therefore
16 the roll call hearing is canceled unless
17 anybody has any questions about anything.

18 MR. RICHARDS: I assume that this
19 is going to go before the Board for the
20 license renewal?

21 MS. FLETCHER: Yes.

22 MR. RICHARDS: And that the

1 settlement agreement will be made a part of
2 the license?

3 MS. FLETCHER: Yes.

4 MR. RICHARDS: And we will receive
5 a copy of the approved thing when the Board
6 acts?

7 MS. FLETCHER: Yes. That's
8 exactly right. The settlement agreement will
9 go on the Board's agenda for review. The
10 Board has to approve settlement agreements.
11 And if the Board reviews it and there are any
12 adjustments they want you to make to it so
13 that it's in compliance with the regulations,
14 they'll let you know.

15 So whether that happens or not,
16 once the Board approves the settlement
17 agreement, yes, Mr. Richards, it becomes a
18 condition of the license. And you will
19 receive a copy of the Board order accepting
20 the settlement agreement and dismissing the
21 protest.

22 Thank you for coming.

1 Any questions, Mr. Wong? Okay.

2 Well, thank you. The roll call
3 hearing is concluded.

4 Thank you for coming.

5 Mr. Richards, is your contact
6 information on that sheet?

7 MR. RICHARDS: Yes.

8 MS. FLETCHER: Okay. Thank you.

9 And Mr. Wong?

10 MR. WONG: It's on there.

11 MS. FLETCHER: Okay. Well, thank
12 you for coming. The hearing is concluded.
13 Thank you very much.
