AGENT FLETCHER: Would the parties in the matter of Kruba please come forward. The parties in the matter of Kruba. This is Case Number 13-PRO-00103.

PoylounG Group, LLC, trading as Kruba, 301 Tingey Street, Southeast, License Number ABRA-090630. This is a Retailer CR, Substantial Change for sidewalk cafŠ application. The protest issues are adverse impact on peace, order and quiet.

My name is La Verne Fletcher and I'll be conducting the Roll Call Hearing as the Board's Agent pursuant to D.C. Official Code 1601.2.

15 MS. EADS-ROLE: Ms. Fletcher?

16 AGENT FLETCHER: Yes.

17 MS. EADS-ROLE: ANC-6D is engaged
18 with the Applicant to reach a settlement
19 agreement on this matter or an amendment to
20 the settlement agreement. ANC-6D's meeting is
21 on September 9th, Monday. If at all possible
22 because the Mediation may not at all be

1 necessary, scheduling Mediation after the 9th
2 of September.

3 AGENT FLETCHER: After the 9th.
4 Okay.

5 We can do it on September the 10th
6 at 11:00. That's a Tuesday. The next
7 available date would be September the 17th at
8 11:00. So, it can be the 10th or the 17th at
9 11:00. Either one is good.

10 MS. EADS-ROLE: September 17.

11 AGENT FLETCHER: The 17th is good?
12 At 11:00? Okay.

13 So, mediation is set for September
14 17 at 11:00.

16 Okay. Thank you for coming. The
17 Roll Call Hearing is concluded. Thank you.
