CHAIRPERSON MILLER: Next case on our calendar is Case No. 13-CMP-00165, Bistro La Bonne located at 1340 U Street, N.W., License No. 75284 in ANC 1B.

MR. ADAMS: Good morning, Madam Chairperson. I'm Walter Adams representing the District of Columbia.

CHAIRPERSON MILLER: Good morning.

MR. LaBONNE: Daniel LaBonne, co-owner of Bistro La Bonne.

CHAIRPERSON MILLER: Good morning. This is a show cause status hearing. I need to ask you if you received notice of this hearing.

MR. LaBONNE: Yes, I did.

CHAIRPERSON MILLER: And did you u read it and understand it?

MR. LaBONNE: Yes, I do.

CHAIRPERSON MILLER: Okay. We're going to make that notice a part of the record

18 LaBonne, do you agree to that Offer in
19 Compromise of \$500 to be paid today?

20 MR. LaBONNE: Yes, I'm in
21 agreement.

22 CHAIRPERSON MILLER: And do you

1 understand that you waive your right to a
2 hearing?

3 MR. LaBONNE: (No audible
4 response.)

5 CHAIRPERSON MILLER: Okay. Any
6 Board questions?

7 (No audible response.)

8 CHAIRPERSON MILLER: All right.
9 Then I move that we approve this Offer in
10 Compromise of \$500 to be paid today. Do I
11 have a second?

12 MEMBER BROOKS: Second.
