CHAIRPERSON MILLER: Okay. Next case on the calendar, Case No. 12-CMP-00562, Food Corner Kabob located at 2029 P Street, N.W., License No. 80108 in ANC 2B.

Good morning.

MR. ADAMS: Good morning. Walter Adams representing the District of Columbia.

MS. SALGUERO: Good morning. My name is Rosemary Salguero and I'm the attorney representative of Food Corner Kabob. This is Javad Abbassi, who's the owner of the establishment.

CHAIRPERSON MILLER: Okay. Great. And I'm sorry, could you repeat your name?

MS. SALGUERO: My name is Rosemary Salguero.

CHAIRPERSON MILLER: Salguero?

MS. SALGUERO: Yes, and I'm the attorney of record.

CHAIRPERSON MILLER: Yes. Oh, and

1 did you file and appearance, too?

2 MS. SALGUERO: I filed it
3 previously for this matter.

4 CHAIRPERSON MILLER: Okay. Great.
5 All right. This is a show cause status
6 hearing, and I just need to ask whether your
7 client received notice of the hearing.

8 MR. ABBASSI: Yes.

9 CHAIRPERSON MILLER: Yes?

10 MR. ABBASSI: Yes.

11 CHAIRPERSON MILLER: You read it
12 and understood it?

13 MR. ABBASSI: Yes.

14 CHAIRPERSON MILLER: Okay. So
15 that notice is going to be part of the record,
16 if there's no objection.

17 (No audible response.)

18 CHAIRPERSON MILLER: Okay. Do we
19 have any preliminary matters?

20 MR. ADAMS: There is a preliminary
21 matter. This case is for the establishment's
22 late filing of a quarterly statement. This is

1 the establishment's first secondary tier
2 violation. Based upon discussions of the
3 parties we've agreed to settle the matter for
4 the payment of a \$500 fine to be paid today.

5 CHAIRPERSON MILLER: Okay. Ms.
6 Salguero, does your client agree to that Offer
7 in Compromise of \$500 to be paid today?

8 MS. SALGUERO: He does.

9 CHAIRPERSON MILLER: Okay. And
10 understands that he waives his right to a
11 hearing?

12 MS. SALGUERO: Yes, he does.

13 CHAIRPERSON MILLER: Okay. Any
14 questions by Board Members?

15 (No audible response.)

16 CHAIRPERSON MILLER: All right.
17 Then I move that we approve this Offer in
18 Compromise of \$500 to be paid today. Do I
19 have a second?

20 MEMBER SILVERSTEIN: Second.

21 CHAIRPERSON MILLER: Mr.
22 Silverstein seconded the motion. All those in

1 favor, say aye?

2 (Chorus of ayes.)

3 CHAIRPERSON MILLER: All those
4 opposed?

5 (No audible response.)

6 CHAIRPERSON MILLER: All those
7 abstaining?

8 (No audible response.)

9 CHAIRPERSON MILLER: The motion
10 passes 4-0-0.

11 You just need to wait for that
12 piece of paper.

13 MS. SALGUERO: Okay.

14 MEMBER ALBERTI: You can sit in
15 the back. You can have a seat in the back.
