CHAIRPERSON MILLER: Okay. The next case has not been canceled. It is Case No. 13-PRO-00087, Hotel Monticello located at 1075 Thomas Jefferson Street, N.W., License No. 89867 in ANC 2E.

Good morning. When you're ready, if you would just identify yourselves for the record?

MS. WILLIFORD: Good morning, Madam Chairman and Members of the Board. My name is Kwamina Williford with Holland & Knight here on behalf of the Licensee, MH Owner, trading as The Graham. And I would just like to note for the record, Hotel Monticello was the former trade name. The current trade name on file is The Graham.

CHAIRPERSON MILLER: The Graham?

MS. WILLIFORD: The Graham, yes.

CHAIRPERSON MILLER: Okay.

MS. WILLIFORD: Thank you.

1 CHAIRPERSON MILLER: All right.

2 MR. BIRCH: Good morning. I'm Tom
3 Birch, Commissioner at ANC 2E-06 here on
4 behalf of the Protestant.

5 CHAIRPERSON MILLER: Okay. Great.
6 Are there any issues you want to bring to the
7 Board's attention?

8 MS. WILLIFORD: Yes, absolutely.
9 The parties had a very productive mediation
10 with Ms. Fletcher July 26th and we're seeking
11 to continue that mediation. We have a
12 scheduled date of September the 10th at 9:00
13 a.m. in hopes that we can resolve the matters
14 before the Board in an amicable way. So we're
15 requesting that the status hearing be
16 continued until potentially September 18th, if
17 that works for the Board, where we can
18 potentially come back before the Board and
19 hopefully say this matter is resolved.

20 CHAIRPERSON MILLER: Okay. We're
21 going to get back to you on that with respect
22 to scheduling another status hearing --

1 MS. WILLIFORD: Okay.

2 MR. BIRCH: Okay.

3 CHAIRPERSON MILLER: -- to make
4 sure that would work out with the calendar.

5 MS. WILLIFORD: Okay.

6 CHAIRPERSON MILLER: But it's
7 noted that you want it moved until September
8 18th.

9 MS. WALKER: It's okay.

10 CHAIRPERSON MILLER: It's okay?
11 Oh, I hear it's okay on the calendar.

12 MS. WILLIFORD: Okay.

13 MR. BIRCH: Great.

14 MS. WILLIFORD: Thank you.

15 CHAIRPERSON MILLER: All right.

16 Done.

17 MR. BIRCH: Thank you.

18 CHAIRPERSON MILLER: And therefore
19 at this point then I don't need to read
20 anything about going forward with the protest
21 hearing. I often go into the instructions,
22 but if there's going to be another hearing --

1 and hopefully this may be resolved by then
2 anyway. But if there is, I'll read those
3 instructions then just about filing your PIFs.

4 MR. BIRCH: And the time will be
5 the same on the 18th?

6 CHAIRPERSON MILLER: 9:30. Yes,
7 it would be.

8 MR. BIRCH: Okay. Thank you.

9 CHAIRPERSON MILLER: And as of now
10 the protest hearing is still scheduled for
11 October 2nd, 4:30 p.m.

12 MR. BIRCH: Fine.

13 MS. WILLIFORD: Yes.

14 MR. BIRCH: All right. Thank you.
