MR. ADAMS: It's the District's understanding that we are aware that the owner did attempt to pay yesterday. However, this case was forwarded to our office based upon a situation where the owner was to pay a fine by

May 24th, 2013 and prior to that point there had been no attempts to pay. So at this point we are going forward with the show cause case. So that's the reason why the owner was not able to pay yesterday. And again, it's our intent to go forward to show cause.

CHAIRPERSON MILLER: Okay. That's my understanding also why the office would have rejected the payment. If you still want to pay, it wouldn't relieve you from the case here.

Okay. So my understanding is the policy is that -- actually they may not accept your payment because of the papering. So it's on record that you said that you wanted to pay then. And I think at this point you need to wait until the show cause hearing is resolved. Okay.
