CHAIRPERSON MILLER: Okay. The next case is Case No. 13-AUD-00031, Mud Dining Saloon located at 723 8th Street, S.E., License No. 71793, in ANC-6B. Oh, excuse me, the full name is The Ugly Mug Dining Saloon. Thank you.

MR. RIVERO: Indulgence, please.

CHAIRPERSON MILLER: All right. All right. Okay. Would you introduce yourselves for the record, please?

MR. RIVERO: Fernando Rivero for the District of Columbia.

MR. JABLONSKI: Gaynor Jablonski, The Ugly Mug.

CHAIRPERSON MILLER: Okay.

MR. JABLONSKI: I never received that. The only thing I received was there was an inspector that came by and dropped off a carbon copy.

MR. RIVERO: Thank you, Board

1 Members. We have a question about service
2 that needed to be resolved. It was unclear.

3 CHAIRPERSON MILLER: Sir, Mr.
4 Jablonski, I know you are being called from
5 different directions, but first of all, can
6 you clarify for the record what your position
7 is with The Ugly Mug Dining Saloon?

8 MR. JABLONSKI: I'm the managing
9 member/owner.

10 CHAIRPERSON MILLER: Okay. And
11 did you sign in?

12 MR. JABLONSKI: I did.

13 CHAIRPERSON MILLER: Okay. Good.
14 And are you all ready to proceed?

15 MR. RIVERO: The Government is
16 ready to proceed. The Board can ask its usual
17 questions.

18 CHAIRPERSON MILLER: Right. Okay.
19 Just wanted to make sure you were finished.
20 Mr. Jablonski, did you receive notice of this
21 hearing?

22 MR. JABLONSKI: Evidently I did.

1 CHAIRPERSON MILLER: Evidently you
2 did?

3 MR. JABLONSKI: Well, I received
4 from an investigator, someone came and dropped
5 off a written -- you know, the little carbon
6 copy sheets of a violation. I have been in
7 contact with Monica Clark about this quarterly
8 report since March and but I never got this.
9 I knew there was a Show Cause Hearing, a
10 Status Hearing, because she told me about it.
11 And she explained to me, you know, what it was
12 for, but I never got this part of it from her.

13 CHAIRPERSON MILLER: What is this
14 part you are referring to? You're referring
15 to the written notice?

16 MR. JABLONSKI: The written notice
17 or these -- the regulation administration, to
18 the best of my knowledge. But I knew of it.

19 CHAIRPERSON MILLER: Okay.

20 MR. JABLONSKI: And I mean, so I
21 know of it, but I can explain to you why I'm
22 here. I have --

1 CHAIRPERSON MILLER: Okay. Wait.
2 We are not getting into the merits here,
3 because it's a Status Hearing. But I do just
4 want to be sure that you had knowledge of this
5 hearing and you understand.

6 MR. JABLONSKI: Yes, I do.
