I'm going to call the next case which is a Show Cause Hearing, Case No. 13-CMP-00135 for 1618 Variety Market located at 1618 8th Street, N.W., License No. 84582, in ANC-6E. Good morning.

MS. SCHMIDT: Good morning.

MR. WELDEGERGISH: Good morning.

How are you?

MS. SCHMIDT: Amy Schmidt, Assistant Attorney General on behalf of the District of Columbia.

MR. WELDEGERGISH: Oh, my name is Medhanie Weldegergish. I'm the owner of 1618 Variety Market, 1618 8th Street, N.W., Washington, D.C. 20001.

CHAIRPERSON MILLER: Okay. And are you the owner?

MR. WELDEGERGISH: Yes, ma'am.

CHAIRPERSON MILLER: Okay. All

1 right. This is a Show Cause Hearing. Do we  
2 have any preliminary issues?

17 MR. WELDEGERGISH: Yes.

18 CHAIRPERSON MILLER: Okay. Any  
19 questions by Board Members? Okay.

20 I move that we approve this offer  
21 in compromise of \$500 to be paid within 90  
22 days.

3 CHAIRPERSON MILLER: Mr. Brooks

20 MR. WELDEGERGISH: Last name W-E-  
21 L-D-E-G-E-R-G-I-S-H.

22 MEMBER ALBERTI: Great. Thank you

1 very much.

2 MR. WELDEGERGISH: You're welcome.

3 CHAIRPERSON MILLER: Okay. We  
4 have just approved it and I have signed it.

5 All right. Thank you very much.

6 MR. WELDEGERGISH: Appreciate it.
