3 CHAIRPERSON MILLER: The next case is
4 Case No. 15-CMP-00358, Java House located at 1645
5 Q Street, N.W., License No. 72780.

6 MR. RIVERO: Good morning, Board
7 Members. Fernando Rivero for the District of
8 Columbia.

9 MR. YAZDANI: My name is Payam
10 Yazdani.

11 CHAIRPERSON MILLER: Are you Mr.
12 Yazdani?

13 MR. YAZDANI: Yes.

14 CHAIRPERSON MILLER: Okay. Okay.
15 This is a Show Cause Hearing (Status) case. Are
16 there any preliminary matters?

17 MR. RIVERO: Yes. The parties have an
18 Offer in Compromise to present to the Board, at
19 this time.

20 CHAIRPERSON MILLER: Okay.

21 MR. RIVERO: And that consists of a
22 fine of \$350 for Charge 1 to be paid within 30

1 days. And if the fine is not paid within 30
2 days, the license will be suspended until the
3 payment is received.

4 CHAIRPERSON MILLER: Okay.

5 MR. RIVERO: And the dismissal of
6 Charge 2.

7 CHAIRPERSON MILLER: Okay. Mr.
8 Yazdani, do you agree to this offer in compromise
9 of a fine of \$350 for the first charge to be paid
10 within 30 days, if not paid within 30 days, then
11 the license would be suspended until paid?

12 MR. YAZDANI: Yes, I do.

13 CHAIRPERSON MILLER: Okay. And do you
14 understand that by entering into an Offer in
15 Compromise, you waive your right to a hearing?

16 MR. YAZDANI: Yes, ma'am.

17 CHAIRPERSON MILLER: And to an appeal?

18 MR. YAZDANI: Yes, ma'am.

19 CHAIRPERSON MILLER: Okay. Any
20 questions? Okay. Then I move that we grant the
21 Offer in Compromise of a fine of \$350 for the
22 first charge to be paid within 30 days. If not

1 paid within 30 days, the license will be
2 suspended until it is paid. And Charge 2
3 dismissed. Do I have a second?

4 MEMBER SHORT: Second.

5 CHAIRPERSON MILLER: Mr. Short has
6 seconded the motion.

7 All those in favor say aye.

8 ALL: Aye.

9 CHAIRPERSON MILLER: All those
10 opposed? All those abstaining? The motion
11 passes 6-0-0.

12 Okay. Okay.
