CHAIRPERSON MILLER: We have another Protest (Status) Hearing Case for The Graham. It's Case No. 13-PRO-00087 located at 1075 Thomas Jefferson Street, N.W.

MR. WOODSON: Good morning, Chairperson Miller, Roderic Woodson from Holland & Knight, and Members of the Board. I'm representing The Graham. If you wouldn't mind, Madam Chairman, may I make a representation?

CHAIRPERSON MILLER: Well, yes. I think I don't see anyone here from the ANC-2E. Do you have some information with respect to the ANC-2E's attendance?

MR. WOODSON: Yes.

CHAIRPERSON MILLER: Okay.

MR. WOODSON: I do. We have discussed this matter. We have been in mediation. Oh, I'm sorry. Take a seat, sign in and do all the requisite things.

1 MEMBER ALBERTI: We need to pick
2 you up on the mike.

3 MR. WOODSON: We have, as the
4 Board may be aware from staff communications,
5 been in active mediation with ANC-2E. We are
6 scheduled for another mediation session
7 tomorrow at 3:30. I think the parties have
8 come quite a ways in all of this since this
9 matter began in the late spring. And I would
10 ask that the -- that's one.

11 And the other is I'm here for both
12 parties, the ANC and the hotel. We discussed
13 this in our last mediation and I agreed to
14 make the appearance for us to inform the Board
15 that we have one more mediation session and we
16 trust that it will breed -- be brought to an
17 amicable conclusion. And we can move forward.

18 If we do not, we already note that
19 the Board has scheduled this matter for a
20 Protest Hearing next month and we could just
21 move forward with the Board's procedural
22 schedule.

1 CHAIRPERSON MILLER: Okay. Are
2 there questions by Board Members? Okay. That
3 sounds good. I'm going to then just schedule
4 this for a Protest Hearing on October 2, 2013
5 at 4:30 p.m. in the event that a settlement is
6 not, by any chance, reached by then.

7 And did you get that date?

8 MR. WOODSON: Yes. We have it on
9 our calendar, Madam Chair.

10 CHAIRPERSON MILLER: Okay. And
11 I'm just going to say briefly, the other party
12 is not here, but you are representing both of
13 them, both parties. And that I want to
14 emphasize that if it does go to hearing, you
15 all need to file your Protest Information Form
16 within seven days of the hearing and serve it
17 on each other. That that form is critical and
18 the Board may, and often -- it seems like it
19 always does, dismiss a case if that PIF has
20 not been filed and served in a timely manner.

21 MR. WOODSON: All right.

22 CHAIRPERSON MILLER: Okay. And if
