CHAIRPERSON MILLER: The next case on our calendar is Case No. 13-CMP-00162, Rose's Dejavu located at 1378 H Street, N.E., License NO. 89342, in ANC-6A.

MS. GEPHARDT: Chrissy Gephardt on behalf of the Office of the Attorney General.

MR. ROBERTS: Danny Roberts on behalf of Rose's Dejavu.

MS. ROBERTS: Veronica Roberts, owner.

CHAIRPERSON MILLER: Okay. And, Ms. Roberts, you're the president or the owner?

MS. ROBERTS: (No audible answer.)

CHAIRPERSON MILLER: Okay. Yes, the president or --

MS. ROBERTS: Yes.

CHAIRPERSON MILLER: Okay. Good. Now, I want to ask you if you received notice of this hearing?

1 MS. ROBERTS: Yes.

2 CHAIRPERSON MILLER: Did you read  
3 it and understand it?

4 MS. ROBERTS: Yes.

5 CHAIRPERSON MILLER: Okay. Then  
6 it is going to become part of the record,  
7 okay, not hearing any objection to that.

8 (Whereupon, the document was  
9 marked as Exhibit 1 for  
10 identification.)

11 CHAIRPERSON MILLER: All right.  
12 Do we have any preliminary matters in this  
13 case?

14 MS. GEPHARDT: Yes, we do have a  
15 preliminary matter. In this case, the parties  
16 have agreed on an offer in compromise. The  
17 offer is a \$700 fine total. This would be a  
18 \$350 fine for Charge 1, a \$350 fine for Charge  
19 2. And Charge 1 should be amended to a  
20 violation of 25-723(d), which is a secondary  
21 tier violation under the statute.

22 CHAIRPERSON MILLER: Okay. And,

1 Ms. Roberts, do you agree to that offer in  
2 compromise of \$700 total, \$350 for Charge 1,  
3 which is amended to read 25-723(d) and \$350  
4 for Charge 2? And before you answer that, I  
5 think we need the time when this will be paid.

6 MS. GEPHARDT: Oh, I apologize.  
7 Oh, that's right, to be payable within 60  
8 days.

9 CHAIRPERSON MILLER: Okay. To be  
10 payable within 60 days.

11 MS. ROBERTS: Yes.

12 CHAIRPERSON MILLER: Okay. And do  
13 you understand you waive your right to a  
14 hearing by accepting this offer?

15 MS. ROBERTS: Yes.

16 CHAIRPERSON MILLER: Yes, okay.  
17 Are there any questions by Board Members?  
18 Okay. Then I move that we accept this offer  
19 in compromise of \$700 total, \$350 for the  
20 first charge, which has been amended to be 25-  
21 723(d) and \$350 for the second charge, all  
22 payable by -- within 60 days of today.

1 Do I have a second?

2 MEMBER SILVERSTEIN: Second.

3 MEMBER BROOKS: Second.

4 CHAIRPERSON MILLER: Mr. Brooks  
5 has seconded the motion.

6 All those in favor say aye.

7 ALL: Aye.

8 CHAIRPERSON MILLER: All those  
9 opposed? All those abstaining? The motion  
10 passes then to accept the offer in compromise  
11 by a vote of 4-0-0.

12 MS. ROBERTS: Thank you.

13 CHAIRPERSON MILLER: Okay. Okay.  
14 Thank you. Okay. That concludes our Show  
15 Cause (Status) Hearing.
