CHAIRPERSON MILLER: The next case is Case No. 11-CMP-00385, Saigon Bistro located at 2153 P Street, N.W., License No. 81175, in ANC-2B.

MR. STERN: Michael Stern for the District of Columbia.

CHAIRPERSON MILLER: Good morning.

MR. NGUYEN: Preston Nguyen on behalf of Saigon Bistro.

CHAIRPERSON MILLER: Is your mike on? Yes, the green light should come up.

MR. NGUYEN: Hello.

CHAIRPERSON MILLER: Okay. Could you repeat your name, please?

MR. NGUYEN: My name is Preston Nguyen and I'm representing for Saigon Bistro.

CHAIRPERSON MILLER: How do you spell your last name?

MR. NGUYEN: Yes, it's N-G-U-Y-E-N.

1 CHAIRPERSON MILLER: And what's
2 your relation to the establishment?

3 MR. NGUYEN: I work there.

4 CHAIRPERSON MILLER: You work
5 there. Okay. All right. Do you have any
6 written authorization to represent Saigon
7 Bistro?

8 MR. NGUYEN: Not on me, but the
9 owner had me come in their stead, because she
10 didn't speak English all that well, so she had
11 me come.

12 CHAIRPERSON MILLER: Okay. At
13 this point, I think, I can only schedule a
14 hearing. Mr. Stern, unless you have something
15 to add. An agreement can sometimes be entered
16 into between the Government and the
17 establishment, but you have to have written
18 authorization to --

19 MR. NGUYEN: Yes, by the owner.

20 CHAIRPERSON MILLER: -- the owner
21 to authorize you to accept that kind of an
22 agreement.

1 MR. STERN: If we may, there
2 actually is an agreement in this case --

3 CHAIRPERSON MILLER: There is?

4 MR. STERN: -- for the parties.
5 So maybe we can schedule this for a further
6 status next week. And the respondent can have
7 the owner come in with him and --

8 CHAIRPERSON MILLER: Or have a
9 written authorization.

10 MR. STERN: Or have a written --

11 CHAIRPERSON MILLER: Either way.

12 MR. STERN: -- authorization.

13 MR. NGUYEN: Okay. Because we are
14 willing to accept --

15 CHAIRPERSON MILLER: Okay. So
16 that's what we will do. We will reschedule
17 this for status for next Wednesday.

18 MR. NGUYEN: Okay.

19 CHAIRPERSON MILLER: All right.

20 Thank you.

21 MR. NGUYEN: Okay. Thank you.
