3 CHAIRPERSON MILLER: Next case is
4 Case Number 13-PRO-00096, Blaguard located at
5 2003 18th Street, Northwest, License Number
6 86012 in ANC 1C. This is Protest Hearing
7 involving termination of settlement agreement.
8 Good morning.

9 MR. MAKRIS: Good morning.

10 CHAIRPERSON MILLER: Would you
11 introduce yourself for the record?

12 MR. MAKRIS: Nic Makris, owner,
13 managing member.

14 CHAIRPERSON MILLER: Okay.

15 MR. KING: Blaine King, owner,
16 managing member.

17 CHAIRPERSON MILLER: All right.

18 MR. JAMES: Denis James,
19 representing Kalorama Citizen's Association.

20 MR. HARK: And Brain Hark for ANC
21 1C.

22 CHAIRPERSON MILLER: Okay. Do you

1 have any preliminary issues you want to bring
2 to our attention? Okay, I want to bring one
3 to attention or whatever.

4 It seems that in this case there's
5 another, that this case was placard twice.
6 And so there's a case for the Blaguard with
7 another number for the same protest. But it's
8 a separate case and that was a mistake.

9 So the Board is only going to
10 proceed with this case and we are going to be
11 issuing an order later today to dismiss case
12 that has number 13-PRO-00125 because it's
13 total duplicative and was a mistake. So that
14 is settled, be taken care of this afternoon.

15 MR. JAMES: I have a question?

16 CHAIRPERSON MILLER: Okay.

17 MR. JAMES: I don't have all the
18 different paperwork in front of me, is that
19 the renewal or the termination?

20 CHAIRPERSON MILLER: This is for
21 termination and the other one is as well.
22 It's just an exact duplicate.

1 So that will be taken care of that
2 way and then if there aren't any other issues
3 were going to schedule this for a hearing
4 November 6th, 2013 at 1:30 p.m.

5 MR. JAMES: November 13th?

6 CHAIRPERSON MILLER: November 6th
7 I have, okay. And you should have your
8 protest information form and packet, if you
9 don't contact Tesha Anderson.

10 As you probably heard me say, but
11 I want to put on the record in this case as
12 well, that that is critical and if you don't
13 file your protest information form and serve
14 it on the other parties within seven days of
15 the hearing, your protest or application will
16 most likely be dismissed. So there's no
17 reason not to do that. And we definitely use
18 that form to determine what's going to be at
19 issue at hearing and to focus on that.

20 Okay, that's it for me then.
21 Thank you very much.
