21 suspended until the fine is paid.

1 MR. WHELAN: I agree with that.

2 CHAIRPERSON MILLER: Okay. And the  
3 licensee understands that it waives its right to  
4 a hearing and appeal?

5 MR. WHELAN: Yes.

6 CHAIRPERSON MILLER: Okay. All right.  
7 Any questions by Board Members?

8 MEMBER SHORT: No.

9 CHAIRPERSON MILLER: Not hearing any,  
10 then I would move that we approve this Offer in  
11 Compromise of a \$350 fine to be paid within 30  
12 days. If not paid within 30 days, the license  
13 will be suspended until payment is made. Do I  
14 have a second?

15 MEMBER SILVERSTEIN: Second.

16 CHAIRPERSON MILLER: Mr. Silverstein  
17 seconded the motion.

20 CHAIRPERSON MILLER: All those
