21 Clarification submitted by Ronald Osten  
22 Chair of ANC 4B, dated September 25th, 2014.

1 It is with respect to Cheerz located at 7303  
2 Georgia Ave. NW, License No.: 095078 and  
3 it's and FYI.

4 CHAIR MILLER: Number 8 is a  
5 Petition for Stay Aboards September 10th,  
6 2014 Order and Stay of Issuance of the  
7 Applicants license pending appeal dated  
8 September 22nd, 2014 submitted by Roderic  
9 Woodson on behalf of Celia Properties. It's  
10 related to DC Eagle located at 3701 Benning  
11 Road NE, License No.: 093984. So I would  
12 move that we deny this Petition because I  
13 don't think it meets the standards for a  
14 study. Is there a second?
