3 CHAIRPERSON MILLER: The next case  
4 is another Show Cause Hearing (Status), Case  
5 No. 13-CMP-00121, Mad Hatter located at 1321  
6 Connecticut Avenue, N.W., License No. 82646,  
7 in ANC-2B.

8 MS. GEPHARDT: Good morning.  
9 Chrissy Gephardt on behalf of the Office of  
10 the Attorney General.

11 MR. ROME: Good morning, Scott  
12 Rome on behalf of the licensee.

13 MR. TOBIN: Michael Tobin.

14 CHAIRPERSON MILLER: Okay. And  
15 you are the owner?

16 MR. TOBIN: Yes, sir. Yes, ma'am.

17 CHAIRPERSON MILLER: Okay. Mr.  
18 Rome, did your client receive notice of the  
19 hearing?

20 MR. ROME: He did.

21 CHAIRPERSON MILLER: Did he read  
22 it and understand it?

1 MR. ROME: Yes.

2 CHAIRPERSON MILLER: Okay. Then  
3 that notice is going to be a part of the  
4 record.

5 (Whereupon, the document was  
6 marked as Exhibit 1 for  
7 identification.)

8 CHAIRPERSON MILLER: Ms. Gephardt,  
9 any preliminary matters?

10 MS. GEPHARDT: Yes, we do have a  
11 preliminary matter in this case. The parties  
12 have agreed on an offer in compromise which  
13 includes a \$1,500 fine and that will be  
14 payable within --

15 MR. ROME: Seven days.

16 MS. GEPHARDT: -- seven days.

17 CHAIRPERSON MILLER: Okay. Mr.  
18 Rome, I just want to confirm that your client  
19 agrees to an offer in compromise of \$1,500 to  
20 be paid within seven days?

21 MR. ROME: That's correct.

22 CHAIRPERSON MILLER: And does he

1 understand that he waives his right to a  
2 hearing?

3 MR. ROME: Yes.

4 CHAIRPERSON MILLER: Okay. Any  
5 questions from Board Members? All right. I  
6 move that we approve this offer in compromise  
7 of \$1,500 to be paid within seven days.

8 Do I have a second?

9 MEMBER BROOKS: Second.

10 CHAIRPERSON MILLER: Mr. Brooks  
11 has seconded the motion.

12 All those in favor say aye.

13 ALL: Aye.

14 CHAIRPERSON MILLER: All those  
15 opposed? All those abstaining? Motion passes  
16 4-0-0 to approve the offer in compromise of  
17 \$1,500 to be paid within seven days.

18 Okay. I have to sign the order.

19 MR. ROME: Okay.

20 CHAIRPERSON MILLER: Wait around  
21 for that for a minute.

22 MR. ROME: Okay.

1 CHAIRPERSON MILLER: Thank you.

2 Okay. That completes this case.

3 MR. ROME: Thank you.

4 CHAIRPERSON MILLER: Thank you

5 very much. And that completes our Status

6 Hearing cases.
