13 great job, great job. I'm glad you did that.

14 I would like to suggest that we do
15 the rest of the Licensing Agenda now.

7 CHAIRPERSON MILLER: All those
8 opposed? All those abstaining? The motion
9 passes 6-0-0.

11 All those in favor say aye.

12 ALL: Aye.

13 CHAIRPERSON MILLER: All those
14 opposed? All those abstaining? The motion
15 passes 6-0-0.

16 No. 7 is an application for a

19 I move that we approve this
20 application. Do I have --

21 MEMBER ALBERTI: Second.

22 CHAIRPERSON MILLER: Mr. Alberti

3 ALL: Aye.

4 CHAIRPERSON MILLER: All those
5 opposed?

6 MEMBER SHORT: Opposed.

7 CHAIRPERSON MILLER: All those
8 abstaining? The motion passes 5-1-0 with Mr.
9 Short dissenting.

10 Okay. And No. 8 is an application
11 for a manager's license for Brian P. Danko,
12 ABRA No. 096808.

13 I move that we schedule Fact-
14 Finding on this one.

15 MEMBER SHORT: Second.

16 CHAIRPERSON MILLER: Mr. Short has
17 seconded the motion.

18 All those in favor say aye.

19 ALL: Aye.

20 CHAIRPERSON MILLER: All those
21 opposed? All those abstaining? The motion
22 passes 6-0-0.

1 Okay. That completes the
2 Licensing Agenda. We have a Supplemental
3 Licensing Agenda.

4 First is a request for stipulated
5 license by Cava Meze Grill located at 707 H
6 Street, N.W., License No. 096402, in ANC-2C.

7 I move that we approve.

8 MEMBER ALBERTI: Second.

9 CHAIRPERSON MILLER: Mr. Alberti
10 seconded the motion.

11 All those in favor say aye.

12 ALL: Aye.

13 CHAIRPERSON MILLER: All those
14 opposed? All those abstaining? The motion
15 passes 6-0-0.

16 No. 2 is a change of hours
17 application by Safeway at 1601 Maryland
18 Avenue, N.E., License No. 075686.

19 I move that we approve.

20 MEMBER SILVERSTEIN: Second.

21 CHAIRPERSON MILLER: Mr.
22 Silverstein seconded the motion.

1 All those in favor say aye.

2 ALL: Aye. All those opposed? All
3 those abstaining? The motion passes 6-0-0.

4 No. 3 is a change of hours
5 application for another Safeway. This one is
6 located at 1747 Columbia Road, N.W., License
7 No. 072708.

8 I move that we approve this
9 application. Do I have a second?

10 MEMBER ALBERTI: Second.

11 CHAIRPERSON MILLER: Mr.
12 Silverstein seconded the motion. I mean, Mr.
13 Alberti seconded the motion.

14 MEMBER ALBERTI: That's all right.
15 I'm not -- that's all right.

16 CHAIRPERSON MILLER: All those in
17 favor say aye.

18 ALL: Aye.

19 CHAIRPERSON MILLER: All those
20 opposed? Okay.

21 No. 4 is another change of hours
22 by a Safeway at 322 40th Street, N.E., License

2 I move that we approve. Do I have
3 a second?

4 MEMBER ALBERTI: I move and
5 second.

6 CHAIRPERSON MILLER: Mr. Alberti
7 seconded the motion.

8 All those in favor say aye.

9 ALL: Aye.

10 CHAIRPERSON MILLER: All those
11 opposed? All those abstaining? The motion
12 passes 6-0-0.

13 No. 5 is a change of hours
14 application for Safeway located at 2845
15 Alabama Avenue, S.E., License No. 060504.

16 I move that we approve. Do I have
17 a second?

18 MEMBER ALBERTI: Second.

19 CHAIRPERSON MILLER: Mr. Alberti
20 seconded the motion.

21 All those in favor say aye.

22 ALL: Aye.

1 CHAIRPERSON MILLER: All those
2 opposed? All those abstaining? The motion
3 passes 6-0-0.

4 And No. 6 is a review of an
5 affidavit of Mr. James T. Redding affiliated
6 with Driftwood Kitchen located at 400 H
7 Street, N.E., License No. 086210.

8 I move that we approve this
9 affidavit. Are we approving the affidavit?

10 MEMBER ALBERTI: No. We are just
11 -- this is actually an FYI.

12 CHAIRPERSON MILLER: Oh, okay.

13 MEMBER ALBERTI: I'll go on the
14 record.

15 CHAIRPERSON MILLER: It has been
16 submitted.

17 MEMBER ALBERTI: This is an FYI
18 and we requested this to complete the
19 materials needed to issue a license for
20 Driftwood Kitchen. And so we are accepting
21 this.

22 CHAIRPERSON MILLER: I guess we

1 can approve that it is satisfactory with
2 respect to --

3 MEMBER ALBERTI: Well --

4 CHAIRPERSON MILLER: -- the
5 affidavit.

6 MEMBER ALBERTI: -- it's
7 satisfactory. Right. We are accepting this
8 as satisfactory --

9 CHAIRPERSON MILLER: Okay.

10 MEMBER ALBERTI: -- to complete
11 the materials for that application.

12 CHAIRPERSON MILLER: Okay. That's
13 good. All right. So I move that we accept
14 it. Do I have a second?

15 MEMBER SILVERSTEIN: Second.

16 CHAIRPERSON MILLER: Mr.
17 Silverstein has seconded the motion.

18 All those in favor say aye.

19 ALL: Aye.

20 CHAIRPERSON MILLER: All those
21 opposed? All those abstaining? The motion
22 passes 6-0-0.

1 Okay. That completes our
2 Licensing Agendas. And we will return and do
3 our Legal Agendas later this afternoon. So we
4 are now going to recess and return for our
5 afternoon Fact-Finding Hearing at 1:30 p.m.
6 Okay.

7 (Whereupon, the above-entitled
8 matter off the record at 12:41 p.m. and
9 resumed at 7:37 p.m.)

10 CHAIRPERSON MILLER: Okay. All
11 right. So we are back on the record to do the
12 Legal Agenda.

13 And we are going to postpone Items
14 1 through 4. Item 1, 2, 3 and 4 deal with
15 Penn Quarter Sports Tavern located at 639
16 Indiana Avenue, N.W., License No. 076039. And
17 they are Motions for Reconsideration in
18 opposition to them and so we are going to deal
19 with that next week.

20 So moving on to No. 5, it's a
21 settlement agreement among ANC-2F, Amoruso
22 Group and Cher Cher Ethiopian Restaurant

1 located at 1334 9th Street, N.W., License No.
2 090311.

3 I move that we approve this
4 settlement agreement.

5 MEMBER RODRIGUEZ: Second it.

6 CHAIRPERSON MILLER: The motion
7 has been seconded by Mr. Rodriguez.

8 All those in favor say aye.

9 ALL: Aye.

10 CHAIRPERSON MILLER: All those
11 opposed? All those abstaining? The motion
12 passes 4-0-0. And that will be issued in
13 Board Order 2014-390.

14 No. 6 is a settlement agreement
15 between ANC-4B and Cheerz located at 7303
16 Georgia Avenue, N.W., License No. 095178.

17 I move that we approve this
18 settlement agreement. Do I have a second?

19 MEMBER BROOKS: Second.

20 CHAIRPERSON MILLER: Mr. Brooks
21 has seconded the motion.

22 All those in favor say aye.

1 ALL: Aye.

2 CHAIRPERSON MILLER: All those
3 opposed? All those abstaining? The motion
4 passes 4-0-0.

5 No. 7 is a petition to
6 unilaterally amend or terminate a settlement
7 agreement. It's for Harris Teeter located at
8 1631 Kalorama Road, N.W., License No. 073993.

9 I move that we placard in order to
10 coincide with the placarding of Harris
11 Teeter's renewal.

12 MEMBER SHORT: Second.

13 CHAIRPERSON MILLER: And Mr. Short
14 has seconded the motion.

15 All those in favor say aye.

16 ALL: Aye.

17 CHAIRPERSON MILLER: All those
18 opposed? All those abstaining? The motion
19 passes 4-0-0.

20 No. 8 is a second amendment to a
21 settlement agreement for Harris Teeter located
22 at 1631 Kalorama Road, N.W., License No.

1 073993.

2 I move that we approve with
3 modifications.

4 All those in favor say aye.

5 ALL: Aye.

6 CHAIRPERSON MILLER: All those
7 opposed? All those abstaining? The motion
8 passes 4-0-0.

9 No. 9 is a Motion to Declare
10 Burden on Petitioner from Roderic Wilson on
11 behalf of Barcode.

12 And I move that we postpone this
13 one until next week.

14 MEMBER SHORT: Second.

15 CHAIRPERSON MILLER: And Mr. Short
16 has seconded that motion.

17 All those in favor say aye.

18 ALL: Aye.

19 CHAIRPERSON MILLER: All those
20 opposed? All those abstaining? Okay. We are
21 going to postpone.

22 MEMBER SHORT: Madam Chair, they

1 didn't spell his name. I guess that's not an
2 issue, right?

3 CHAIRPERSON MILLER: Oh, did they?
4 Oh, Wilson, right. That should be Woodson.

5 MEMBER SHORT: Woodson.

6 CHAIRPERSON MILLER: Yes. That
7 should be corrected for the record, W-O-O-D-S-
8 O-N. Thank you. All right.

9 And No. 10 is a letter of support
10 for Terminal Alley dated September 25, 2014
11 that was submitted by Councilmember Alexander.
12 And it is with respect to Terminal Alley
13 located at 3701 Benning Road, N.E., License
14 No. 093986.

15 And this is just an FYI.

16 MEMBER SHORT: Second.

17 CHAIRPERSON MILLER: No, it's just
18 an FYI, so we don't need to vote on it.

19 Okay. So that's the Legal Agenda.
20 Okay. We have a Supplemental Legal Agenda.
21 Actually, we are going to be postponing until
22 next week all items except for No. 5.

1 So being postponed is a request
2 for consideration with to Pi located at 2309
3 18th Street, N.W..

4 No. 2 is also a petition for
5 reconsideration or clarification with respect
6 to Pi.

7 No. 3 is an opposition to the
8 Motion to Declare Burden on Petitioner for
9 Barcode that was on the previous regular Legal
10 Agenda.

11 And No. 4 also deals with the
12 Barcode Motion to Declare Burden on
13 Petitioner.

14 So those four will be postponed, I
15 think, by consensus of the Board, why don't we
16 just say that.

17 No. 5, I move that we approve the
18 Emergency Rulemaking for Adams Morgan
19 Moratorium Zone.

20 Do I have a second?

21 MEMBER BROOKS: Second.

22 CHAIRPERSON MILLER: Mr. Brooks

1 has seconded the motion.

2 All those in favor say aye.

3 ALL: Aye.

4 CHAIRPERSON MILLER: All those
5 opposed? All those abstaining? The motion
6 passes 4-0-0.

7 No. 6 and 7 also will be postponed
8 until next week.

9 No. 6 is the Proposed Rulemaking
10 for Administrative and Technical Rulemaking.

11 And No. 7 is Proposed Rulemaking
12 for Chapter 16 of the DCMR.

13 And I say that's by consensus of
14 the Board. Okay.

15 So we have one more Second
16 Supplemental Licensing Agenda item, it's a
17 request for cancellation of a license in ANC-
18 6B. It's Li'l Pub located at 655 Pennsylvania
19 Avenue, S.E., License No. 001875.

20 I move that we approve this
21 cancellation. Do I have a second?

22 MEMBER SHORT: Second.

1 CHAIRPERSON MILLER: Mr. Short has
2 seconded the motion.

3 All those in favor say aye.

4 ALL: Aye.

5 CHAIRPERSON MILLER: All those
6 opposed? All those abstaining? The motion
7 passes 4-0-0. And this decision will be
8 issued in Board Order No. 2014-396.

9 So that completes the Legal Agenda
10 and all that we have left is to vote on closed
11 meetings for next week.

12 As Chairperson of the Alcoholic
13 Beverage Control Board for the District of
14 Columbia and in accordance with Section 405 of
15 the Open Meetings Amendment Act of 2010, I
16 move that the ABC Board hold a closed meeting

7 MEMBER BROOKS: I agree.

8 CHAIRPERSON MILLER: Mr.
9 Rodriguez?

10 MEMBER RODRIGUEZ: I agree.

11 CHAIRPERSON MILLER: Ms. Miller
12 agrees.

13 Mr. Short?

14 MEMBER SHORT: I agree.

15 CHAIRPERSON MILLER: It appears
16 that the motion has passed by a 4-0-0 vote.

17 I hereby give notice that the ABC
18 Board will hold this aforementioned closed
19 meeting pursuant to the Open Meetings
