4 on the Board's calendar is Case No. 12-CMP-
5 00144, Lion's Fine Wine & Spirits located at
6 3614 Georgia Avenue, N.W., License No. 88221,
7 in ANC-1A.

8 Is anybody here for Lion's Gate?

9 Ms. Phillips, do you want to
10 introduce yourself for the record?

11 MS. PHILLIPS: Louise Phillips,
12 Assistant Attorney General for the District of
13 Columbia.

14 CHAIRPERSON MILLER: Do you have
15 any information with respect to whether
16 someone from Lion's Fine Wine & Spirits are on
17 their way or anything like that?

18 MS. PHILLIPS: I do not. I know
19 that they did not contact Ms. Zaniel as
20 indicated that they should in the notice. So
