



THIS AMENDMENT TO VOLUNTARY AGREEMENT is made on this 14th day of January 2013 by and between Washington Drama Society, Inc. t/a Arena Stage, License #1729 (Licensee), and Advisory Neighborhood Commission ANC6D, (collectively, the Parties).

RECITALS

WHEREAS, Applicant and ANC6D entered into a Voluntary Agreement dated September 13, 2010 concerning the Licensee's Retailer's Class CX alcoholic beverage license for an establishment located at 1101 6th Street, SW, Washington, D.C.; and

WHEREAS, in the Original Voluntary Agreement, ANC6D requested and Licensee agreed to specific controls regarding the Hours of Operation and Sales of Alcoholic Beverages; and

WHEREAS, the Parties have agreed to enter into this Amendment to Voluntary Agreement to permit the Licensee to extend its Hours of Operation and Sales of Alcoholic Beverages to the extent permitted by law; and

WHEREAS, the Parties request that the Alcoholic Beverage Control Board approve this Amendment to Voluntary Agreement conditioned upon the Licensee's compliance with the terms of this written Amendment and the previously executed Voluntary Agreement; and

NOW, THEREFORE, in consideration of the recitals set forth above, it is mutually understood and agreed by and between the undersigned Parties to amend the previously executed Voluntary Agreement as follows:

1. ***Recitals Incorporated.*** The recitals set forth above are incorporated herein by reference.
2. ***Hours of Operation and Sales.***

The Applicant's Hours of Operation for selling and serving alcohol shall be as follows:



conditions of the previously executed Voluntary Agreement are expressly reaffirmed and remain in full force and effect.





VOLUNTARY/COOPERATIVE AGREEMENT

THIS VOLUNTARY AGREEMENT (“Agreement”) is made on this 13th day of September 2010 by and between Washington Drama Society t/a Arena Stage (“Applicant”), and Advisory Neighborhood Commission 6D (“Protestant”), (collectively, the “Parties”).

PREAMBLE

Through this agreement, both parties aim to create an environment in which the Applicant may operate as a viable contributing establishment in the ANC6D community.

WITNESETH

WHEREAS, Applicant has applied to bring out of safekeeping Retailer's Class CX Multipurpose ABRA License #1729 for a business (live theater) (“Establishment”) located at 1101 Sixth Street, S.W., Washington, D.C. 20024 (“Premises”); and

WHEREAS, The Applicant will manage and operate an Establishment with three live performances spaces in the The Fischandler, The Kreeger, and The Cradle theaters; two concession areas: concessions without tables and cafe with tables; a rooftop outdoor seating/eating area; and special events spaces in the lobby and rooftop areas – these areas include a total of 1394 seats and an occupant load of 2553; and

WHEREAS, the hours of operation of the Establishment for theater events includes regular matinee and evening performances during which time the food and liquor sales will be available prior to performances and during intermission and occasional post-performances as follows: Sunday 11:30 am-12:00 am; Monday 5:00 pm - 12:00 am; Tuesday through Thursday 10:00 am - 12:00 am; Friday and Saturday 10:00 am 12:30 am; and

WHEREAS, the Applicant will make space in the Establishment available to other groups for special catered events when performances are not scheduled; and

WHEREAS, the Applicant has management contracts with several catering firms for food and alcohol sales for both the regular theater events as well as special events wherein the contractor/caterer will be responsible for ID check regarding alcohol sales; and

WHEREAS, the Applicant agrees that it will abide by Title 25 and other DC laws relating to alcohol sales and service, including, itself or through a caterer contractor: confirming age of

patron to whom alcoholic service is provided; prevention of overserving of patrons; prevention of patron rowdiness; prohibition of taking alcoholic beverage out of the establishment; prohibition of loitering; ensuring appropriate training regarding service of alcoholic beverage to employees of caterers, licensed manager, all employees, and volunteers, if applicable; maintaining written log of all incidents (including description of the incident, date, time, names and contact information for victim, perpetrator, any witnesses, and the resolution of the incident) and making log available to representatives of MPD and ABRA on request; and

WHEREAS, the Applicant agrees to work regularly with ANC6D and its representatives, other neighborhood organizations, and residents to ensure that the business operations facilitate the enjoyment of the surrounding neighborhood. In this regard, Applicant agrees to maintain open communication with the Protestants, and the community for which the ANC acts. The Protestants encourage Applicant to send representatives to attend the regular meetings of ANC6D which currently occur on the second Monday of each month (except August when there is no meeting, and October when the meeting is on the third Monday) at 7:00 p.m. at St. Augustine's Church, at 6th and M Streets, SW, Washington, D.C. 20024; and

WHEREAS, All parties believe that the statements and provisions contained in this agreement are reasonable and shall become wholly integrated into the day-to-day operation of the Establishment. Any change from this model shall be considered by both Parties to be a substantial change in operation of great concern to residents and requires prior approval by the ABC Board; and

WHEREAS, the Parties are desirous of entering into a Voluntary Agreement pursuant to D.C. Official Code § 25-446 for the operation and maintenance of the Establishment in such a manner as to minimize the effect, within the ANC, on (i) the peace, order and quiet of the neighborhood and (ii) parking, pedestrian safety and vehicular traffic, to protect the interests of the neighborhood, its residents and other businesses, and to eliminate the need for a Protest Hearing regarding the license application. Further, Applicant, upon notice from the ANC, shall send a representative of the Establishment to a meeting(s) to confer and deal in good faith with issues raised under this Agreement. and

WHEREAS, the Parties have agreed to enter into this Agreement and request that the Alcoholic Beverage Control Board ("ABC Board") approve the Applicant's license application conditioned upon the Applicant's compliance with the terms of this written Agreement;

NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and conditions set forth below, the Parties agree as follows:

1. **Recitals Incorporated.** The recitals set forth above are incorporated herein by reference.
2. **Parking/Valet Arrangements.** It is a principal concern of the Protestants that the Applicant's operation of the Establishment does not create or exacerbate parking problems within the ANC boundaries. We recognize that Applicant has a limited number

of spaces at its property for vehicular parking and that often a large number of patrons and attendees of special events will be expected; therefore, we encourage the Applicant to notify patrons that street parking is very limited and inform them that convenient public transportation is available, i.e., Subway Green line to Waterfront Station, and the 70 and Circulator bus routes.

3. **Noise and Privacy.** Applicant will strictly comply with D.C. Official Code § 25-725 and to that end shall take all necessary actions to ensure that music, noise and vibration from the Establishment (including the rooftop space) are not audible within the adjacent residential properties. There shall be no live music in the rooftop space.
4. **Public Space and Trash.** Applicant shall keep the sidewalk (up to and including the curb), tree box(es), curb, and alley clean and free of litter and other debris in compliance with D.C. Code and Municipal Regulations. Applicant shall monitor these areas to assure that refuse and other materials are promptly removed. The Applicant uses an indoor dumpster that does not encroach on the abutting property owners and agrees that no garbage will be placed on the abutting property.
5. **Security Cooperation in Stemming Illegal Drugs and Public Drinking.** Protestants are concerned that the large capacity expected to attend events on the Premises may pose security and crime issues. Applicant agrees that it shall take all necessary steps to minimize such problems, including, designating a sufficient number of TIPPS-trained employees to assure adequate security, whether inside or in the immediate outside area; monitoring for and prohibiting sales or use of illegal drugs within or about the Premises, maintaining contact and cooperating with MPD and other enforcement officials when known or suspected drug activities occur. Applicant shall to the full extent permissible by law discourage loitering in the vicinity of the Premises. Applicant has security cameras in several locations which record and store information for at least 30 days whose recordings shall be made available to representatives of ABRA and/or MPD.
6. **License Ownership and Compliance with ABRA Regulations.** Applicant promises to Protestants that it shall abide by all Alcoholic Beverage Regulations Administration (ABRA) regulations regarding the ownership of the license and all other provisions applicable to liquor licensees, and agrees that Protestants shall have standing to ask the ABC Board to enforce any violations of the agreement. Applicant also specifically agrees to be the sole owner of the ABC license.
7. **Notice and Opportunity to Cure.** In the event that any of the parties is in breach of this Agreement, it shall be entitled to reasonable notice and opportunity to cure, as a condition precedent to seeking enforcement of the Agreement. Unless the breach is of an emergency nature or is a repetition of a prior breach, reasonable notice and opportunity shall provide for a cure within 30 days of the date of such notice. If Applicant or the licensee fails to cure within the 30-day period (or, with respect to a breach which reasonably requires more than 30-days to cure, fails to commence cure of such breach

and diligently pursues such cure) failure shall constitute a cause for seeking a Show Cause Order from the ABC Board pursuant to D.C. Official Code § 25-447. Unless otherwise noted above, any notices required to be made under this Agreement shall be in writing and mailed via certified mail, return receipt requested, postage prepaid, or hand-delivered, to the other parties to this Agreement at the following addresses. Notice shall be deemed given as of the time of receipt or refusal of receipt:




- 14. **Withdrawal of Protest.** Upon execution of this Agreement by the Parties and its acceptance by the ABC Board, Protestants shall withdraw the Protest.
