CHAIRPERSON MILLER: Okay, the next case is a show cause status hearing.

It is Case Number 12-CMP-00393(a), Chief Ike's Mambo Room, located at 1723 Columbia Road NW, License Number 18940 in ANC 1C.

MR. RIVERO: Good morning, Board members, Fernando Rivero for the District of Columbia.

MR. KLINE: Good morning, Andrew Kline on behalf of the licensee.

CHAIRPERSON MILLER: Good morning. Mr. Kline, did your client receive notice of this hearing?

MR. KLINE: He received notice, read it, understands it, and waives any required formal reading.

CHAIRPERSON MILLER: Okay, good. Mr. Rivero, are there any preliminary matters in this case?

1 MR. RIVERO: Well, there might be
2 if the licensee appeared this morning. We
3 have made progress towards an OIC, but we're
4 not quite sure why the licensee is not yet
5 here.

6 CHAIRPERSON MILLER: Okay. Did
7 you want us to come back to this case? Or do
8 you want to just have, otherwise I'll just
9 schedule it for hearing and --

10 MR. RIVERO: The Government will
11 wait until the last hearing.

12 CHAIRPERSON MILLER: Right.

13 MR. RIVERO: And then we can call
14 it then. And if the licensee's still not
15 here, then we can schedule for show cause.

16 CHAIRPERSON MILLER: Okay.

17 MR. KLINE: That's fine.

18 CHAIRPERSON MILLER: That is the,
19 let me ask you how long you want to wait, the
20 last status hearing or the last morning
21 hearing?

22 MR. RIVERO: The last status

1 hearing.

2 CHAIRPERSON MILLER: Status, okay.

3 MR. RIVERO: That's to clarify.

4 CHAIRPERSON MILLER: Okay, we'll
5 call you back at that one then.

6 MR. RIVERO: Okay.

7 CHAIRPERSON MILLER: Thank you.

8 (Whereupon, the foregoing matter
9 went off the record at 9:49 .m. and went back
10 on the record at 10:00 a.m.)
11 (10:00 a.m.)

12 CHAIRPERSON MILLER: So, I believe
13 I'm re-recalling Chief Ike's Mambo Room,
14 right? That's the case? Okay.

15 We were waiting to see if the
16 Licensee might appear. It's 9:58 and the
17 hearing was called for 9:30. And we finished
18 all the other statuses. So I assume the
19 Licensee is not here.

20 MR. KLINE: The Licensee is not
21 here. I am here as his representative,
22 however.

1 And we, given that obviously can't
2 agree to an OIC that was given here, we
3 request that the matter be set for hearing.

4 If in the meantime, we're able to
5 work something out, we will certainly let the
6 Board know through its Counsel. And perhaps
7 we can get it resolved before the parties
8 prepare for hearing.

9 CHAIRPERSON MILLER: That's right.
10 Yes, you can come in another Wednesday if you
11 get it all resolved.

12 All right then, this is Chief
13 Ike's Mambo Room, Case Number 12-CMP-
14 00393(a). The matter is scheduled for show
15 cause hearing January 22nd, 2014, at 1:30
16 p.m.

17 MR. KLINE: Thank you.

18 CHAIRPERSON MILLER: Thank you.

19 MR. RIVERO: 1:30?

20 CHAIRPERSON MILLER: 1:30.

21 MR. RIVERO: Okay.
