
ORDER ON VOLUNTARY AGREEMENT





At its meeting on August 13, 2003, the Dupont Circle Advisory Neighborhood Commission (Commission or ANC 2B) considered Substantial Change Application #32910, by Magic Meals, Inc., T/A Oodles Noodles, for ABC service at a sidewalk café located at 1120 19th Street, NW. With eight of nine commissioners in attendance, a quorum at a duly called public meeting, the following motion was unanimously approved:

ANC 2B supports ABC Substantial Change Application #32910, by Magic Meals, Inc., T/A Oodles Noodles, for ABC service at a sidewalk café located at 1120 19th Street, NW, subject to a voluntary agreement addressing issues related to the dimensions of the sidewalk café. ANC 2B further supports an immediate stipulated licence should the terms of the voluntary agreement be finalized.

Attached is a properly signed and executed voluntary agreement addressing the concerns of ANC 2B. We respectfully request that the Board stipulate the conditions of the agreement in the licence. Please note that this letter serves to document the Commission's support for a stipulated licence to immediately serve ABC-regulated beverages.
