CHAIRPERSON MILLER: I'm going to call Case No. 13-PRO-00131, Washington Firehouse. That's located at 1626 North Capitol Street, N.W., License No. 92685 in ANC 5E and this is a new application.

I know we have a lot of parties in this case. If you need to pull up an additional chair, feel free to do that, or two.

And be sure to sign in, everybody, at some point before you leave. All right, why don't we start with introductions over there.

MR. BAYLOR: Hello, my name is Vincent Baylor, the general manager at The Firehouse.

CHAIRPERSON MILLER: You're the general manager?

MR. BAYLOR: Yes.

1 CHAIRPERSON MILLER: Okay.

2 MR. OSTADHOSSEINI: Good morning,  
3 Abdol Ostadhosseini, I'm the owner. Abdol  
4 Ostadhosseini.

5 CHAIRPERSON MILLER: And how are  
6 you related to the establishment?

7 MR. OSTADHOSSEINI: I am the owner  
8 of the restaurant.

9 CHAIRPERSON MILLER: Owner, okay.

10 MS. QUINN: I'm Teri Janine Quinn  
11 and I'm the Commissioner for ANC 5E06 and the  
12 president of the Bloomingdale Civic  
13 Association.

14 MS. YOUNG: My name is Jane Young  
15 and I'm a resident on 14 Quincy Place.

16 CHAIRPERSON MILLER: Which party  
17 are you here with? You're all the Group of  
18 11? Ms. Quinn is Group of 11?

19 MS. QUINN: No.

20 CHAIRPERSON MILLER: No.

21 MS. QUINN: ANC 5E.

22 CHAIRPERSON MILLER: I'm sorry,

1 right, got it.

2 And what was your name?

3 MS. YOUNG: Jane, J-A-N-E, Young,  
4 Y-O-U-N-G. Group of 11.

5 MS. BOND: Aisha Bond, also a  
6 resident, Group of 11.

7 MS. LEWIS: Karla Lewis, resident,  
8 85 R Street, Group of 43.

9 CHAIRPERSON MILLER: What's your  
10 last name, I'm sorry?

11 MS. LEWIS: Lewis, L-E-W-I-S.

12 CHAIRPERSON MILLER: Lewis, okay.

13 MS. LYNCH: Felicia Lynch,  
14 representative of Group of 11.

15 MS. McDANIEL: Mary McDaniel,  
16 Group of 43.

17 CHAIRPERSON MILLER: Okay. I have  
18 in my notes that a Group of 11 was granted  
19 conditional standing. At roll call, two more  
20 needs to appear today and those two are here?  
21 Who was that?

22 MS. BOND: Aisha Bond.

1 MS. YOUNG: Jane Young.

2 CHAIRPERSON MILLER: So you two  
3 weren't at the roll call?

4 MS. BOND: That's correct.

5 CHAIRPERSON MILLER: Okay, great.  
6 All right. Your Protest Hearing is scheduled  
7 for December 4, 2013 at 1:30 p.m., if you  
8 don't settle.

9 Do you have a question? You  
10 thought it was a different time?

11 MS. LEWIS: According to the email  
12 that was sent out.

13 CHAIRPERSON MILLER: Okay, you got  
14 an email that said December 4th at 4:30?

15 MS. QUINN: Yes.

16 CHAIRPERSON MILLER: Let me see if  
17 I can verify. It's 1:30 now. It's 1:30 now.

18 MS. BOND: It's been changed.

19 CHAIRPERSON MILLER: It's 1:30.  
20 If you were told something else, that's a  
21 mistake. This is the correct time.

22 Okay, is there anything else you

1 need to bring to our attention, you can do so  
2 now. Otherwise, I'm just going to give you  
3 the same words about preparing for the Protest  
4 Hearing, and that is that you should have  
5 gotten in the mail something from Tesha  
6 Anderson and her contact number is 442-6942,  
7 if you need to contact her between now and  
8 then. But you should have gotten a protest  
9 information form and that's a very important  
10 form for the protest. Pay attention to that.  
11 You need to articulate your issues succinctly  
12 and identify your witnesses so there aren't  
13 any surprises at the hearing if it goes to  
14 hearing. And you need to send a copy to every  
15 party in the case and also the Board seven  
16 days ahead of the hearing. That's very  
17 important. Don't fool around with that  
18 because cases have been dismissed for failure  
19 to submit that on time. Any questions?

20 MS. QUINN: I just wanted to note  
21 that the prior incorrect time was from Ms.  
22 Anderson.

1 CHAIRPERSON MILLER: Okay. I  
2 understand. Supposedly, it was corrected on  
3 October 21st. General counsel told me. But  
4 if you have any doubt or any questions as you  
5 get close to the hearing, feel free to check  
6 in with her or Martha Jenkins, who is our  
7 general counsel.

8 MS. QUINN: Great.

9 CHAIRPERSON MILLER: Thank you  
10 very much.

11 MR. OSTADHOSSEINI: Thank you.

12 (Whereupon, at 9:47 a.m., the  
13 Protest Hearing (Status) was concluded.)
